### **INTRODUCTION:**

This item is to request the City Council to approve a Resolution amending the City Engineer Consultant Services Contract Amendment No. 2

## **BACKGROUND:**

On May 18, 2021, The City Council approved Amendment No. 1 to Contract 2015-01-01, Agreement for City Engineering Consultant Services (Joseph G. Gaffney Civil Engineering). That amendment extended the existing contract until December 31, 2021 and budgeted \$15,000 for City Engineer services through the end of the calendar year.

### **DISCUSSION:**

The City Engineer performs a variety of services for the City. Many of those services are paid for through developer deposit accounts and are thus not an impact on the General Fund. However, many of the services are not covered by deposit accounts and are charged to the General Fund. Such services include attendance at City Council and other meetings, representation of the City on the Groundwater Sustainability Agency Advisory Committee, coordination with Caltrans for downtown improvements, and many others.

When the FY 21-22 Budget was formulated, an amount for City Engineer services was included and budgeted for \$30,000. In practice, this amount has proven to be short of the actual fees involved. Rather than cut back on City Engineer services, many of which are vital to the City, a contract amendment No 2 to tap the remainder of the \$30,000 budgeted is requested.

As of November 8, 2021, the City Engineer has also submitted a letter of resignation effective December 31, 2021, which is also the end of his current contract. The City has accepted his resignation and in the process of transitioning all of his pending projects to GHD to ensure there will be no interruptions to any of the pending capital projects that are currently in the pipeline.

### GOALS:

• This action supports the following City Council Goals and General Plan Actions: Operate City government in a fiscally responsible and responsive manner.

### **PUBLIC COMMENT:**

As of the writing of this staff report, the City has not received any public comment. However, public comment from interested parties following the publication and distribution of this staff report will be provided to the City Council as supplemental materials before or at the meeting. In addition, a consent calendar item may be requested to be removed from the consent calendar if a member of the Council or public requests to provide public comment on this item.

### PUBLIC NOTICE:

This item was noticed in accordance with the Ralph M. Brown Act and was available for public viewing and review at least 72 hours prior to schedule meeting date.

### FISCAL IMPACT:

The approved Engineering Department budget for FY 21-22 included \$30,000 for Engineer consultant services funded by the General Fund. With the approval of Amendment No. 1 to the City Engineer contract, the budget through the end of the calendar year was set at \$15,000. As of November 2021, Mr. Gaffney's billings for City Engineer through the end of October 2021 for a total of 15,232.50 which has exceeded the allotted amount of \$15,000. Based upon the transition workload through December 31, 2021, it is proposed to use the remainder of the budgeted amount of \$15,000 to continue the transition duties of this position without interruptions.

The City Engineer also invoices against deposit accounts. Deposit accounts are established for the prepayment of expenses related to development review, conceptual planning, or any other planning, reviews, inspections as deemed necessary by the city as well as invoices against capital project.

### **RECOMMENDATION:**

By Resolution, approve a Contract Amendment No. 2 in the amount of \$15,000 for City Engineer services.

WHEREAS, as the current contract terminates on December 31, 2021, it is proposed that this Contract Amendment No. 2 include an addition of \$15,000 for transitioning of any pending projects due to resignation.

NOW, THEREFORE, BE IT RESOLVED that the City Council hereby authorizes the City Manager to execute Amendment No. 2 to Contract No. 2015-01-01, Agreement for City Engineering Consultant Services (Joseph G. Gaffney Civil Engineering) for services through December 31, 2021 and approves a budget amendment for an additional \$15,000.

# AMENDMENT NO. 2 TO MASTER AGREEMENT 2015-01-01 FOR ENGINEERING CONSULTING SERVICES TO EXTEND TERM OF AGREEMENT Joseph G. Gaffney Civil Engineering
