INTRODUCTION/PURPOSE:

The item is to request Council adoption of a Resolution approving a budget amendment to the Fiscal Year 2023-24 Capital Improvement Program (CIP) Budget for Bodega Avenue Bike Lanes and Rehabilitation Project 0513-74.09 (the Project) and authorize City Manager to approve contract change orders up to 20% of the contract amount.

BACKGROUND AND DISCUSSION:

Council on May 16, 2023, awarded the construction contract to Argonaut Constructors and authorized 10% of the contract for contingencies during construction. On June 20, 2023, Council approved the Green Valley Consulting Engineers contract for construction management and inspection. Other construction support service contracts approved under the City's procurement policy include: 1) construction engineering and environmental compliance; and 2) materials compaction testing. A contract change order (CCO 1) for unforeseen underground conditions was approved within the City Manager's approval authority and CIP budget in the amount of \$49,042.

During work and in preparation for street pavement overlay it was discovered in the bid documents for work items to adjust the iron covers of existing utility manholes and boxes to the new pavement elevation the quantity of manhole covers was undercounted and for utility boxes was missing. The elevation adjustments to the iron covers are necessary to provide a uniform and smooth pavement overlay. The estimated cost to adjust the iron covers is \$88,000 and will require approving of a contract change order to do the work. Approval of a change order to adjust the iron covers, however, is outside of the City Manager's approval authority of 10% of the contract that was authorized at the time of bid award. The additional costs would also exceed the CIP Budget for the Project.

Staff is requesting: 1) a budget amendment to the Fiscal Year 2023-24 CIP Budget to account for the added costs described above for adjusting the iron covers of existing utility manholes/boxes and construction engineering support services; and 2) authorizing the City Manager to approve contract change orders up to 20% of the contract amount. Table 1 below is a summary of construction costs for the Project.

FISCAL IMPACT:

The adopted CIP budget for Fiscal Year 2023-24 for Bodega Avenue Bike Lanes and Rehabilitation Project 0513-74.09 is \$1,245,000. The proposed budget amendment of \$103,700 to accommodate the change order to adjust iron covers and construction engineering support services described above is proposed to be funded as listed below shown in Table 1 below:

WHEREAS, City Council on May 16, 2023, awarded the construction contract to Argonaut Constructors and authorized 10% of the contract for contingencies during construction; and

WHEREAS, additional budget is needed to fund the total cost of construction of Bodega Avenue Bike Lanes and Rehabilitation Phase 1 Project, which includes construction, construction management and inspection, construction engineering and environmental compliance and materials compaction testing; and

WHEREAS, a budget amendment to the adopted Fiscal Year 2023-24 Capital Improvement Program (CIP) budget to proposed expenditures and funding sources is necessary for incorporating cost changes due to unforeseen field conditions and addition of items of work required to complete Bodega Avenue Bike Lanes and Rehabilitation Phase 1 Project but not included in the initial bid documents; and

WHEREAS, on June 20, 2023, City Council adopted the Fiscal Year 2023-24 CIP Budget for Bodega Avenue Bike Lanes and Rehabilitation Phase 1 Project #CIP 0513-74.09 for construction and inspection in the amount of \$1,245,000; and

WHEREAS, the adopted and proposed amended budget to incorporate cost changes as described above and required to complete Bodega Avenue Bike Lanes and Rehabilitation Phase 1 Project is shown in Table 1.
