INTRODUCTION:

This item is to request City Council Consider A Budget Amendment for the Relaunch Sebastopol Contract.

BACKGROUND:

On October 19, 2021 the City Council approved a Request for Proposals (RFP) for a Relaunch Sebastopol contract to manage and coordinate a variety of organizations and interests towards a common goal of increased community vitality. The Council authorized \$86,000 towards hiring of a contract employee or consultant to not only identify steps the City can take to promote the creation of a robust retail environment in the City, work with cross-promoting events, but also create City events to showcase Sebastopol and enhance community engagement and cross-promoting of events.

City staff released the Request for Proposals with the goal to hire professional consultant or contract employee to develop and sustain a strong local economy to provide business and residents with, among other things, the necessary municipal services to maintain the community's high quality of life. The awardee would carry out the tasks in the RFP to enhance community and economic vitality for Sebastopol and coordinate a variety of organizations and interests towards a common goal of increased community vitality.

At the January 19, 2022 City Council Meeting, the City Council approved award of contract to Townie Media in the amount of \$86,000.

DISCUSSION:

As the Council is aware, the City has transferred risk management from the former Redwood Empire Municipal Insurance Fund (REMIF) to California Intergovernmental Risk Authority (CIRA). As CIRA reviews insurance submitted to the City for contracts, based upon review of the insurance provided from Townie Media, CIRA has requested that the contract be amended to include that "Insurance must be maintained and evidence of insurance must be provided for at least a minimum of year after completion of the contract of work. If coverage is canceled or non-renewed, and not replaced with another claims-made policy form with a Retroactive Date prior

to the contract effective date, the Consultant must purchase "extended reporting" coverage for a minimum of one year after completion of contract work. A copy of the claims reporting requirements must be submitted to the Entity for review."

City staff has reviewed the insurance response from CIRA and concurs with CIRA that the additional insurance coverage is required to ensure that CIRA would represent the City in case a claim was made after the ending date of the contract. City staff have been in discussion with CIRA and Townie Media regarding this requirement for a resolution. As this is a requirement that the City has not seen before for a "claims made" insurance policy and was not made a part of the contract proposal, as well as the work that the scope of work proposed by Townie Media (fostering business development; attracting consumers to visit; promoting Sebastopol as a great place to live, work and visit; encouraging existing property owners to reinvest in their buildings; creating a "City day" picnic for the community to bring businesses and community together or utilizing empty businesses to create "pop up" events; and working with the local schools for community hour projects to beautify the City (Park/Street clean up, murals on benches/garbage cans, painting of City light poles, etc.) which are intended to bring in revenues to the City, City staff believes that the revenues to the City budget based on the Proposal by Townie Media will exceed the requested cost to maintain the insurance a year beyond the contract ending date and is therefore recommending the City Council authorize a not to exceed amount of \$10,000 for the cost of the additional coverage beyond the contract end date. The City has not yet signed the contract for Relaunch Sebastopol as this insurance issue need to be resolved. Authorizing the budget amendment of a not to exceed amount of \$10,000 will allow the City to execute the contract and begin the Relaunch Sebastopol activities.

City staff has met with the Relaunch Sebastopol Ad Hoc Committee who support this request for additional funding.

NOW, THEREFORE, BE IT RESOLVED that the City Council hereby authorize an amendment of not to exceed \$10,000 in the City Council Account 100-10-01-4210 and authorizes the City Manager to execute payment to Townie Media for said coverage upon submittal of invoice.
