#### INTRODUCTION/PURPOSE:

This item is to request that the City Council Consider and Approve the Request from the Sebastopol Area Chamber of Commerce for Approval of Resolution authorizing the closure of Main Street during the 2023 Apple Blossom Parade, Saturday, April 29, 2023, the use of the South High Street Parking Lot for the Apple Blossom Festival and suspending section 201 of ordinance no. 696 during the 2023 Apple Blossom Festival, Saturday, April 29 and Sunday, April 30, 2023.

### **BACKGROUND:**

Each year, the Chamber of Commerce requests from the City of Sebastopol approval for the closure of Main Street for the Apple Blossom Parade, the use of the South High Street Parking Lot for the Apple Blossom Festival, suspending section 201 of ordinance no. 696 during the Apple Blossom Festival and requests the Department of Transportation grant permission to hold a parade on Main Street, State Highway Route 116 (04-Son-116) between Healdsburg Avenue and Calder Avenue from 9:30 am to 1:00 pm on Saturday (day of the Parade).

#### DISCUSSION:

The Annual Apple Blossom Parade will be held on Saturday, April 29, 2023 and the Apple Blossom Festival will be held on Saturday, April 29 and Sunday, April 30, 2023. For these events, the Sebastopol Area Chamber of Commerce has requested permission for the following:

Permission from the City Council to close Main Street to hold the parade on Saturday, April 29, 2023; The
Chamber will be required to obtain a City Encroachment Permit from the Public Works Department, and
an Encroachment Permit from the California Department of Transportation (Caltrans), and meet all City
insurance requirements.

- Permission from the City Council to use the South High Street Parking Lot for the Apple Blossom Festival.
- The licensing of solicitors, street peddlers, and vendors be suspended on April 29 and 30, 2023, for the Apple Blossom Festival.

#### RESOLUTION NO. XXXX-2023

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEBASTOPOL
APPROVING THE CLOSURE OF MAIN STREET (STATE HIGHWAY 116) AND
REQUESTING THAT THE STATE HIGHWAY BE CLOSED FOR A PARADE ON SATURDAY, APRIL 29, 2023
AND THE USE OF THE SOUTH HIGH STREET PARKING LOT FOR THE 2023 APPLE BLOSSOM FESTIVAL
AND SUSPENDING SECTION 201 OF ORDINANCE NO. 696 DURING THE 2023 APPLE BLOSSOM
FESTIVAL, SATURDAY, APRIL 29 AND SUNDAY, APRIL 30, 2023

WHEREAS, the Sebastopol Area Chamber of Commerce has requested the Council to designate Saturday, April 29, 2023 for the Apple Blossom Parade and to procure necessary approval to allow a parade to be held and conducted on April 29, 2023, by said Chamber upon MAIN STREET (STATE HIGHWAY 116); and

WHEREAS, the Sebastopol Area Chamber of Commerce has requested that Main Street, between Healdsburg Avenue and Calder Avenue, be closed for the annual Apple Blossom Parade; and

WHEREAS, the Sebastopol Area Chamber of Commerce has requested the use of the South High Street parking lot for the Apple Blossom Festival; and

WHEREAS Section 201 of Ordinance 696 provides among other things, the suspension of street vendors / solicitation licensing during time of special events in the City of Sebastopol where the circumstances would otherwise result in a substantial increase in the use of City streets or other public facilities; and

WHEREAS, the City Council of the City of Sebastopol finds that that it is in best interest of the community and the city that the annual Apple Blossom Parade and Festival event proceed.

### NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED AS FOLLOWS:

- 1. Sebastopol City Council grants permission to the Sebastopol Area Chamber of Commerce to hold and conduct a parade (Apple Blossom Parade) on Saturday, April 29, 2023; and
- 2. Sebastopol City Council requests the Department of Transportation grant permission to hold a parade on Main Street, State Highway Route 116 {04-Son-116} between Healdsburg Avenue and Calder Avenue from 10:00am to 1:00pm on Saturday, April 29, 2023; and
- 3. Sebastopol City Council grants permission to the Sebastopol Area Chamber of Commerce to use the South High Street parking lot for the Apple Blossom Festival, Saturday, April 29 and Sunday, April 30, 2023; and
- 4. The licensing of solicitors, street peddlers, and vendors shall be suspended on April 29 and 30, 2023, for the area designated as Exhibit A attached herto and incorporated herein by reference, with the inclusion of the Jewell Avenue Island and that during the period of such suspension, such licenses shall not be issued by the City of Sebastopol. Such suspension shall not apply to sales or other activities directly pertaining to the Apple Blossom event itself, when sanctioned by the Sebastopol Chamber of Commerce; and
- 5. The Council does hereby order that the Sebastopol Area Chamber of Commerce work with the Sebastopol Police and Sebastopol Public Works Departments for control or detour of public traffic as may be necessary for the safe and expeditious movement of public traffic and for the safety of the participants in the parade; and
- 6. That certified copies of this resolution, together with other necessary transmittal documents, are directed to be forwarded to the Department of Transportation of the State of California.

#### ORDINANCE NO. 696

AN ORDINANCE AMENDING ORDINANCE NO. 396 AND 688 AMENDING CERTAIN SECTIONS OF THE BUSINESS LICENSE ORDINANCE AND REPEALING ORDINANCES IN CONFLICT THEREWITH

THE CITY COUNCIL OF THE CITY OF SEBASTOROL DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 20(L) of Ordinance No. 596 as further

amended by Ordinance No. 688 shall be amended to read as follows:

Section 20 L. Solicitors, street peddlers, or yendors, shall pay the sum of \$150.00 per year subject to the modifications set forth below:

- 1. The above rates shall apply to each individual solicitor and such licenses are not transferrable.
- 2. This section shall not apply to that class of persons ordinarily called travelling men who sell by sample to the trade only, but shall apply to all other persons, firms or individuals, or corporations who either sell or deliver from place to place or who conduct or establish a place of business or vend upon the streets or who solicit or deliver by truck or other containers to the trade when the same is done over the streets of the forty of Sebastopol.
- 3. This section of the ordinance way be suspended by resolution of the City Council and upon such suspension all licenses of solicitors, street peddlers, and vendors shall be suspended in the specific area and for the specific period as the Council way determine by seid resolution.
- 4. The Council may adopt such resolution when there are special events in the City and where the circumstances will result in a substantial increase in the use of the City streets or other public facilities. Said suspension shall not exceed five days at any one time.
- 5. During such period of suspension, the following regulations shall apply and shall be set forth in the resolution:
  - A City may issue special vandor, solicitor or street peddler licenses during such period of suspension in the quantity to be determined in said resolution and for the period of such suspension.
