# Additional Open Positions/Discussion of Additional Recruitment

In addition to appointments for the positions open as of November 2022, the CAC and staff are requesting the Council provide direction on the following:

Business owner representative -- The current business owner representative, Deborah Burnes, is remaining on the Committee. However she would like to transition to being the Planning Commission's representative rather than the business owner representative based on planning commission discussions. Therefore, an additional business owner representative is desired. No applications for this position were received in the current recruitment.

Additionally, the second youth member, Argus Brent, recently announced his resignation, so there is an additional youth position available.

The CAC has discussed the vacancies in the Youth position, and are actively recruiting at the high school, and the business owner representative. The City staff has received one application after the recruitment time, and interest from youth. Therefore, staff recommends that, in addition to appointments tonight, that the City readvertise for recruitment for CAC vacancies in the following categories:

- Youth representative (2 vacancies)
- Business representative (1 vacancy)
- Environmental Justice (1 vacancy)

These recruitments could be either a standard recruitment time (6 weeks with potential 2-week extension if needed) or 'until filled'. If 'until filled', the vacancies would be listed on the City's website and any applications would be referred to the Council upon receipt for interviews and potential appointment. This could also assist with the Environmental justice position, which has never been filled, and the youth positions, which often experience vacancies due to students graduating/leaving the area for college, etc.

Goal 5.1.4 Enhance the use of the City of Sebastopol Committees, Commissions and Boards.

#### **PUBLIC COMMENT:**

As of the writing of this staff report, the City has not received any public comment. However, staff anticipates receiving public comment from interested parties following the publication and distribution of this staff report. Such comments will be provided to the City Council as supplemental materials before or at the meeting. In addition, public comments may be offered during the public comment portion of this item.

### **FISCAL IMPACT:**

There is no direct fiscal impact associated with the recommended action tonight.

#### **RECOMMENDATION:**

Staff recommends that the Mayor and Council make appointments to fill vacancies as listed above. Staff further recommends the Council determine whether to reopen the environmental justices position or leave unfilled at this time. (If re-advertised, staff recommends, based on input from CAC members, that the position be posted as 'open until filled'.)
