








North Bay Area Electric Vehicle Incentives

There are several incentives which may apply to your vehicle or EVSE purchase/installation. Review eligibility requirements to determine if you or your new vehicle will qualify.

* Subject to actual tax burden. Maximum tax credit requires minimum of \$7,500 in taxes owed (paid or due) for the calendar year. For new cars: income max of \$150k single, \$225k head of household, \$300k joint. For used cars: income max of \$75k single, \$112.5k head of household, \$150k joint. \$55k maximum price for cars, \$80k maximum price for minivans, SUVs, Trucks. Used models must be at least 2 model years old and cost \$24, or less. Qualifying new vehicles must meet requirements of critical minerals and battery components if purchased after April 18.

** Higher-income earners: income max of \$135k single, \$175k head of household, \$200k joint. Lower-income owners: household income below \$54,360 (plus \$18,880 for each additional household member). Subject to fund availability. Vehicle must be \$45k or less for cars, \$60k or less for SUV/Truck/Van—FCEV are exempt from price cap.

§ Requires purchase of qualifying new or used EV within last six months. For qualifying household incomes.

† Must be a Sonoma Clean Power customer and non-profit. \$15,000 for passenger vehicles. Vehicle must be co-branded with SCP logo and be used by multiple members of the organization.

†† Must live in an eligible community served by Bay Area Air Quality Management District. Must trade in qualifying old car to be dismantled. Maximum vehicle sales price: \$48,000. Used replacement vehicles must have model years within 8 years of the current calendar year.
