Subject: Resolution Stating City's Opposition to AT&T Applications: Relief of "Carrier of Last

Report" and Eligible Telecommunications Carrier Designation.

RECOMMENDATIONS: That the City Council consider the request from Councilmember Maurer for Approval of Resolution stating the City's Opposition to AT&T Applications: Relief of "Carrier of Last Report" and Eligible Telecommunications Carrier Designation.

EXECUTIVE SUMMARY:

AT&T has requested to be relieved of its Carrier of Last Resort (COLR) obligations in certain areas of California. If approved, AT&T California (landline service, separate from cellular) would no longer be required to offer landline telephone service where it is currently required to offer Basic Service in those areas. Basic Service includes nine service elements such as Lifeline rates for eligible customers, free access to 9-1-1, Telephone Relay Service, and directory and operator services.

BACKGROUND AND DISCUSSION:

A COLR is a telecommunications service provider that stands ready to provide basic telephone service, commonly landline telephone service, to any customer requesting such service within a specified area. At least one telephone company in a specified area is legally required to provide access to telephone service to anyone in its service territory who requests it. This is known as the Carrier of Last Resort (COLR) obligation, which ensures that everyone in California has access to safe, reliable, and affordable telephone service. AT&T is the designated COLR in many parts of the state and is the largest COLR in California. Where AT&T is the default landline telephone service provider means that the company must provide traditional landline telephone service to any potential customer in that service territory. AT&T is proposing to withdraw as the COLR in your area without a new carrier being designated as a COLR.

An area without a COLR could mean that there would be no landline telephone company serving that area and that there could possibly be no landline telephone access for customers in that area. If AT&T's proposal were accepted as set forth in its application, then no COLR would be required to provide basic service in your area. This does not necessarily mean that no carriers would, in fact, provide service in your area—only that they would not be required to do so. Other outcomes are possible, such as another carrier besides AT&T volunteering to become the COLR in an area, or the CPUC denying AT&T's proposal.

In addition, on March 3, 2023, AT&T requested to give up its designation as an Eligible Telecommunications Carrier (ETC). An ETC is a telephone company operating in a specific geographic area, that receives financial assistance from the federal government-established Universal Service Fund to provide high quality, and affordable telephone service to customers at all income levels in specific geographic areas. One example of a program funded by the Universal Service Fund is federal Lifeline. While funding for this program is provided by the federal government, each state determines a telephone company's eligibility for ETC designation. In California, a company's eligibility for these federal funds is determined by the CPUC.

AT&T is applying to give up its ETC designation, which would allow it to no longer offer federal Lifeline, as well as other federal programs designed to subsidize telecommunications support for low-income individuals and individuals located in remote areas. AT&T's participation in the California LifeLine program is a separate matter from this application to give up its ETC designation. AT&T asserts that it is not necessary to keep its ETC designation because it no longer receives any federal high-cost support from the federal government to provide universal service. By relinquishing its ETC designation, AT&T will no longer be eligible to receive federal support to provide Lifeline, which could potentially affect all current AT&T Lifeline customers.

Per information received from Councilmember Maurer, the Santa Cruz Board of Supervisors (SC BOS) adopted a resolution asking the CPUC to deny AT&T's applications to discontinue landline service. This proposed resolution for Sebastopol is adapted in part from the SC BOS resolution. It differs in that it references local emergency situations. The City of Berkeley also opposes AT&T landline withdrawal as well as the Town of Fairfax opposing the same.

Sebastopol is partially served with fiber optics, and also served by copper cable. See attached map, which was taken from: https://www.broadbandsearch.net/service/california/sebastopol. Councilmember Maurer has confirmed with Sonic that most of the outer areas of Sebastopol are still served by copper. She has also stated that if AT&T discontinues maintenance of the copper lines, residents and businesses are at risk of losing not only landlines, but also internet service.

Councilmember Maurer has provided additional information to this report as well as a DRAFT Resolution for consideration.

COMMUNITY OUTREACH:

This item has been noticed in accordance with the Ralph M. Brown Act and was available for public viewing and review at least 72 hours prior to schedule meeting date. The City has also used social to promote and advertise the City Council Meeting Agenda Items.

FISCAL IMPACT:

There is no fiscal impact with the action requested tonight.

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEBASTOPOL
REQUESTING THE CALIFORNIA PUBLIC UTILITIES COMMISSION
DENY AT&T'S APPLICATIONS TO BE RELIEVED OF ITS CARRIER OF LAST
RESORT AND ELIGIBLE TELECOMMUNICATION CARRIER DESIGNATIONS

WHEREAS, AT&T has submitted applications, A.23-03-002 and A.23-03-003, through the California Public Utilities Commission (CPUC) to be relieved of its Carrier of Last Resort (COLR) and Eligible Telecommunication Carrier (ETC) designations in certain areas of California including Sebastopol and surrounding areas without identifying an alternative carrier to assume responsibility for maintaining the landline communication services¹, ² and

WHEREAS, a COLR obligation ensures that everyone in California has access to safe, reliable, and affordable telephone service; and

WHEREAS, an ETC is a telephone company operating in a specific geographic area, that receives financial assistance from the federal government established Universal Service Fund to provide high quality, and affordable telephone service to customers at all income levels in specific geographic areas; and

WHEREAS if approved, AT&T would have no obligation to ensure reliable access to 9-1-1 or LifeLine program discounts; and

WHEREAS landline phones can be more reliable than Voice Over Internet Protocol (VOIP) and wireless cell phones for emergencies, especially during a power outage³; and

WHEREAS during the 2017 Tubbs Fire in Santa Rosa over 70 cell towers were knocked out of operation⁴ and wireless emergency notifications during the 2018 Camp Fire failed⁵; and

WHEREAS, residents and businesses in Sebastopol, including the City of Sebastopol depend on landline phones.

AT&T's Applications for Targeted Relief from its Carrier of Last Resort Obligation and Relinquish its Eligible Telecommunications Carrier Designation (A.23-03-003 and A.23-03-002)

AT&T's application regarding Carrier of Last Resort Obligations (A.23-03-003)

In this application, AT&T requests to be relieved of its Carrier of Last Resort (COLR) obligations in certain areas of California. If approved, it would no longer be required to offer landline telephone service where it is currently required to offer Basic Service in those areas. Basic Service includes nine service elements such as Lifeline rates for eligible customers, free access to 9-1-1, Telephone Relay Service, and directory and operator services. More information on Basic Service is available at https://www.cpuc.ca.gov/industries-and-topics/internet-and-phone/broadband-mapping-program/broadband-public-feedback/basic-service-definition.

What is a Carrier of Last Resort (COLR)? A COLR is a telecommunications service provider that stands ready to provide basic telephone service, commonly landline telephone service, to any customer requesting such service within a specified area. At least one telephone company in a specified area is legally required to provide access to telephone service to anyone in its service territory who requests it. This is known as the Carrier of Last Resort (COLR) obligation which ensures that everyone in California has access to safe, reliable, and affordable telephone service. AT&T is the designated COLR in many parts of the state and is the largest COLR in California. Where AT&T is the default landline telephone service provider means that the company must provide traditional landline telephone service to any potential customer in that service territory. AT&T is proposing to withdraw as the COLR in your area without a new carrier being designated as a COLR.

What areas are impacted by AT&T's request to withdraw as a COLR? Here is the list of census designated places where AT&T is requesting to withdraw as the designated COLR and here is an online version of the map with address lookup.

What might happen if AT&T withdraws as a COLR? An area without a COLR could mean that there would be no landline telephone company serving that area and that there could possibly be no landline telephone access for customers in that area. If AT&T's proposal were accepted as set forth in its application, then no COLR would be required to provide basic service in your area. This does not necessarily mean that no carriers would, in fact, provide service in your area—only that they would not be required to do so. Other outcomes are possible, such as another carrier besides AT&T volunteering to become the COLR in your area, or the CPUC denying AT&T's proposal.

AT&T's application regarding Eligible Telecommunication Carrier Designation (A.23-03-002)

On March 3, 2023, AT&T requested to give up its designation as an Eligible Telecommunications Carrier (ETC).

What is an ETC? An ETC is a telephone company operating in a specific geographic area, that receives financial assistance from the federal government-established Universal Service Fund to provide high quality, and affordable telephone service to customers at all income levels in specific geographic areas. One example of a program funded by the Universal Service Fund is federal Lifeline. While funding for this program is provided by the federal government, each state determines a telephone company's eligibility for ETC designation. In California, a company's eligibility for these federal funds is determined by the CPUC.

Does an ETC provide California LifeLine? In California, the CPUC also approves and denies applications for state funding for programs to provide universal support, including California LifeLine (California's program is called LifeLine with a capital "L" for "Line"). The California LifeLine program is separate from the federal Lifeline program. An ETC may be a provider of California LifeLine as well as federal Lifeline, but eligibility to provide California LifeLine is not limited to only ETC providers.

What is AT&T's request in this application? AT&T is applying to give up its ETC designation, which would allow it to no longer offer federal Lifeline, as well as other federal programs designed to subsidize telecommunications support for low-income individuals and individuals located in remote areas. AT&T's participation in the California LifeLine program is a separate matter from this application to give up its ETC designation. AT&T asserts that it is not necessary to keep its ETC designation because it no longer receives any federal high-cost support from the federal government to provide universal service. By relinquishing its ETC designation, AT&T will no longer be eligible to receive federal support to provide Lifeline, which could potentially affect all current AT&T Lifeline customers.

What areas are impacted by AT&T's request to give up its ETC designation? All areas of AT&T's service territory where it currently holds ETC designation, which is the same as its Carrier of Last Resort (COLR) service territory, could be impacted if the CPUC approves AT&T's application. What are the potential impacts on customers' bills? For a household receiving federal Lifeline from AT&T, the bill could increase by \$5.25 per month for voice-only service, or \$9.25 per month for bundled or internet service. In addition to these amounts, a household on Tribal lands receiving federal Lifeline from AT&T could experience an additional \$25 per month bill increase.

What is required of AT&T for the CPUC to approve AT&T's request? AT&T must demonstrate that another ETC provider can provide universal support in the areas where AT&T wishes to surrender its ETC designation.

SUMMARY OF PARTY POSITIONS

AT&T California's COLR Application Summary

Beginning in the 1990s, there has been a transition from AT&T California's local telephone monopoly to today's voice service offerings provided by a variety of providers, wired and wireless. In 1996, to ensure that everyone could receive phone service during the transition, the Commission assigned AT&T California to be the carrier of last resort ("COLR") and required it to extend its copper network to any location in its service territory. Now, twenty-seven years later, after about 90 percent of AT&T California's former customers have left its plain old telephone service ("POTS") for voice services over mobile wireless or broadband connections, AT&T California has filed an application with the California Public Utilities Commission to end its COLR obligation and the associated state regulatory requirements in areas that are served by another voice provider.

The outdated COLR obligation effectively forces AT&T California to maintain its old copper-wire network to provide POTS throughout its service territory—in addition to the modern fiber and wireless broadband networks AT&T is working to extend across California.

The enormous benefits of transitioning from copper to broadband are beyond dispute. High-speed broadband enables online learning, remote work, economic advancement, civic engagement, Next Generation 911 capabilities, and access to government and other services. Fiber networks also are more resilient and use less energy than copper networks, benefiting public safety and the environment. In short, the faster this transition occurs, the better it will be for California.

Almost all (99.95 percent) consumers in AT&T California's service territory live in areas with at least one comparably or lower-priced broadband (for example, cable company) or mobile wireless voice alternatives to POTS (and 99.9 percent live in areas with at least two alternatives available). These customers with other options do not need AT&T California to be the COLR—especially since mobile wireless and broadband voice support 911 dialing, access for people with disabilities, and other critical functions as well as or better than POTS.

AT&T California will continue providing POTS services to customers for at least six months after approval of the Application. AT&T California will provide notice before any changes to customers' POTS services. For the few customers who currently lack an alternative, AT&T California will continue offering voice service on the same terms after approval of its application until an alternative arrives. Approval of the application thus would harm no one while bringing major benefits to California communities.

WHAT IS THIS PROCEEDING ABOUT?

- At least one telephone company in your area is legally required to provide access to phone service to anyone in its service territory who requests it. This is known as the Carrier of Last Resort (COLR) obligation which ensures that everyone in California has access to reliable phone service. AT&T is the designated COLR in your area.
- AT&T is asking the CPUC to allow it to decide whether you can get AT&T telephone service, even if there is no other telephone provider in your area who is obligated to provide service.

Despite improvements since Tubbs Fire emergency notifications remain imperfect

One of the most glaring lessons from the Tubbs Fire was the failure to warn those in its path. Concerned that blanket alerts would cause massive traffic jams, officials hesitated. The results were tragic. Much work has been done in the close to four years since, but issues remain.

Living three and a half miles up a dead end road between Sugar Loaf Ridge and St Helena Rd, Gary Liess figured he might be on his own in a major wildfire. Following 2017s Tubbs Fire, he became more vigilant; removing brush, creating defensible space.

One evening last year, as the Glass Fire burned out of control over the ridge to the east, a neighbor, who'd been assessing the distant flames from his motorcycle, drove up with an ominous

warning.

"He said you've got maybe four hours before it gets here," Liess said.

An hour later, he saw spot fires exploding downhill to the west, far ahead of the main fire. He raced home, rounded up their cats and some electronics. His wife Carolyn insisted they leave immediately.

"She had seen the documentary on that, I think it was the Paradise, how people y'know dicked around for an extra five, ten, fifteen minutes and didn't make it out," he said.

Recalling it months later, he remembers no warnings from the tv, radio, calls or texts, though at some point, his phone was in another room. He credits his neighbor for being able to escape less than 90 minutes before his home of three decades was obliterated.

Three years after the emergency warning system failed so dramatically during the Tubbs Fire, Liess's experience shows issues remain.

It's up to Sam Wallis, with the county's Department of Emergency Management to fix those issues. Since the Tubbs fire, the county doesn't count on a single person to issue alerts. More people are trained, and they aren't dependent only on the sheriff's dispatch center. A system of wildfire cameras can alert officials faster. Still, other problems remain, and fixing them is no easy task.

"Technology is a two edged sword," Wallis said. "There are many things that we have right now that are so much superior to what we had even five or ten years ago, we just have some amazing capabilities, but from an emergency management point of view, things have in many ways been getting worse."

Old Civil Defense sirens aren't widely missed, as they couldn't convey much other than something was happening. Landline phones, which operated on their own, low voltage electricity have been mostly phased out.

"We now have this really remarkable cell phone technology, we have voice over internet, all these just wonderful technological things that make our communications so much easier, but they're fragile. Remarkably fragile. One of the things that came out of the Nuns/Tubbs Fire is that we had over 70 cell phone towers knocked out of operation at the very moment when we most needed to be able to communicate with people," Wallis said.

Lengthy power shutoffs during high fire danger could leave many cell phones, and the towers connecting them discharged. But even when everything is working, there are gaps.

With permission from the FCC and FEMA, a test of one of the alert systems---called WEA...was held last winter in Oakmont.

"We found that only about 60 percent of the participants actually received the WEA. And this was when they knew it was coming and we set everything up, Wallis said.

WEA allows short texts to go out to every phone in a given area. It's different from SoCo Alert, which can send longer, more precise information, but only to those who have signed up. It's also slower. But Wallis says even WEA, which unlike SoCo alert local officials don't have full control over, is imperfect.

"In theory, everyone within range of that cell phone tower will receive that message. In practice however, what we found is that for a variety of reasons, some cell phones will not receive that message," Wallis said.

Dead zones, discharged batteries, and people disregarding messages from an unfamiliar source. That's all doubly true with SoCo Alert which sends alerts as ordinary texts.

"Something as simple as somebody put their do-not-disturb on their cell phone, or they have an older cell phone that doesn't have a software update, the system won't work or it could be that they happen to be in a cell shadow when it happens, Wallis said.

That's not to mention tourists or those reluctant to opt-in.

Despite active publicity campaigns, Wallis said fewer than 30 percent of county residents have signed up. But he says, about three times that are on the list anyway, as officials added in numbers gathered in utility databases and other sources. When alerts do go out, they don't always go through. Do-not-disturb settings are one reason, but incessant spam, spoof and telemarketing calls and texts are an even bigger impediment.

That's part of the reason high-low sirens have been added to many law enforcement vehicles. It's also why Santa Rosa is giving out weather radios...redundancy. But they also won't work if the power is off and batteries dead.

"If there was a magic button, that I could press and make 100% of the people get the message, definitely, I will hit that button, but that button, as of yet, does not exist," Wallis said.

Nevertheless, Wallis said the county is more prepared than ever. "I'm feeling much more confident going into this fire season than I did previous fire seasons. We have tools, we have a process, we have information sources that we didn't have in previous fire seasons. The alert and warning will go out. I may not get to 100 percent, but I'm sure going to get as close as I can to it."

Months after losing his home, Gary Liess is philosophical about all the loss.

"I'm not looking at it, oh, I lost my house, I'm looking at it I am grateful to have lived a great portion of my life in this tremendous environment. This is awesome. For me. So, yeah, OK, it's over, I get it. On to the next thing, y'know, so, I get to have another adventure," Liess said.

Camp Fire Aftermath: 'Technology, the Thing I Trust Most, Failed'

Technology intended to warn Butte County residents about the rampaging Camp Fire failed in several ways, an analysis shows, revealing the fragility of electronic notification systems.

Residents of Paradise bitterly complained in the wake of the Camp Fire that Butte County's early warning system failed them, and now a detailed Bay Area News Group analysis shows just how thorough that failure was: Thousands of critical cellphone messages were missed, delayed or lost — a disturbing reminder of the fragility of electronic notifications systems.

"The system failed. Technology, the thing I trust most, failed," said Lisa Parr, an accountant who had signed up to get the county's emergency alerts but never received one. "The system that was supposed to help save us — it didn't."

This news organization's review found problems at every level — many residents didn't sign up for the system, officials didn't trigger warnings for every neighborhood, and overloaded or damaged cellular networks often failed to deliver warnings to the intended recipients.

A Butte County spokeswoman said Sheriff Kory Honea will conduct an analysis and issue a report when time allows.

"I wish we had opportunity to get more alerts out, more warning out," Honea said during a community meeting on the third day of the fire. "We try to use as many systems as we can. ... But in the heat of this, it was moving so fast, it was difficult to get that information out."

To better understand how the failures occurred, this news organization requested evacuation alert records from the Paradise and Chico police departments and from Butte County, as well as cell tower information from the California Public Utilities Commission.

A review of alerts issued by the county and Paradise police in the hours after the fire started on Nov. 8 shows that, inexplicably, no evacuation orders were issued by the county to one 6-square-mile swath of the city. Another 4-mile stretch of town received merely a warning; the actual order to flee came more than seven hours later, long after homes were reduced to ashes.

Prior to the Camp Fire, only an estimated one-quarter of the region's residents had signed up to get emergency messages — but even when they signed up, many calls didn't reach them.

Success varied from geographical zone to zone, generally deteriorating as the fire spread and the infrastructure was damaged or overwhelmed. Even in the best-performing zones, 25 percent of alerts did not make a connection to the resident's phone. In the worst zone, the call failure rate was 94 percent.

Seventeen cell towers burned that first day, according to records obtained from the CPUC. During the first two weeks of the fire, a total of 66 cellphone towers were damaged or out of service, causing phones to go silent or calls to be dropped as surviving towers became overloaded by traffic.

"We really need to get better at this," said disaster expert Kelly McKinney, author of the book *Moment of Truth: The Nature of Catastrophes and How to Prepare for Them.* McKinney urges the creation of a state system to provide a notification template and backup help for local responders.

"The public needs to understand what to expect — what will happen, when it will happen and who is accountable for making it happen," said McKinney, former deputy commissioner at New York City's Office of Emergency Management. "If you don't have those three things, it is wishful thinking. And wishful thinking always fails you in a disaster."

Paradise and its surrounding communities — where 86 people perished in the fire — is not the only place where planning has not been up to the task. In other California disasters, alerts and evacuations have fallen short, including the 2017 flooding of downtown San Jose and Tubbs Fire of Sonoma County, which killed 22. In last January's mudslides in Montecito, a message was issued while hillsides already were collapsing, killing more than 20 people.

In the San Francisco Bay Area, the public warning systems are a patchwork of technologies, personnel, media, vendors and policies, and there are both duplications and gaps in their coverage, according to a 2017 report by the Bay Area Urban Areas Security Initiative, a federally funded project to improve the region's capacity to respond to catastrophic events. As a result, the messages people receive in one city are often different than those in another.

"California's alert system is, in reality, 58 county alert systems duct-taped together, with 58 different processes and capabilities," said McKinney.

"If we're going to remove the duct tape and bolt and wire it together, so it's all one machine, the state has to do it."

New state laws aim to improve notification in the future. One mandates statewide guidelines and training programs for local governments. Another authorizes counties to automatically enroll residents into emergency notification systems, gaining access to phone numbers through utility bills and other services.

In Paradise, only residents who had registered for CodeRED, the county's alert system, had any chance of knowing what was happening during the Camp Fire. County logs from Nov. 8 through Nov. 10 show that messages reached 16,683 phones but failed to reach 11,057 despite repeated attempts. Paradise Police reached a total of 4,855 phones but did not reach 3,930. Combined, authorities also sent more than 6,000 texts and 6,700 emails that first day, with additional alerts issued in the days following. An estimated 38,702 people lived in the towns of Paradise, Magalia and Concow, with others scattered in more rural parts of the county.

counties, connecting to landlines, cellphones, emails and social media.

There is a second type of alert system, also available to Bay Area counties, where notifications such as Amber Alerts can be sent to cellphones regardless of whether residents have opted-in. This system, the Federal Emergency Management Agency's Wireless Emergency Alert (WEA), blankets an area with a warning.

But WEA's geographical targeting, based on a labyrinth of cell towers and a honeycomb of tower signal "sectors," is not terribly precise. Any WEA alert will likely overshoot or undershoot the desired alert area.

Both systems are vulnerable. They rely on local officials, who are inevitably overwhelmed in the early hours of a catastrophe, scrambling to save lives and get resources to the danger, according to McKinney. As the fire consumed Paradise, thousands of calls poured in to 911 — where only two dispatchers were working.

In Paradise, officials issued evacuation alerts for 10 different zones in the city in just one hour, between 7:47 a.m. and 8:43 a.m. But alerts were not sent in four other zones, equally at risk. The Butte County Sheriff's Office, which issued the alerts throughout the county, referred questions about the four zones to Paradise Police, who did not respond to a request for comment.

"It'll never be perfect when there's limited time," said Daniel Gonzales of the RAND Homeland Security and Defense Center, who led a 2016 study about warnings for the U.S. Department of Homeland Security. But with review and more pre-planning and practice, "it should be possible to do much better than what happened in Paradise ... to minimize errors that might happen during a very stressful set of conditions."

To improve matters, officials will have to solve one weakness of any electronic alert system: its dependence on electricity.

Even during a power outage, messages that are sent to a landline have a better chance of getting through. That's because power is sent to the phones through copper wires, which are more heat-resistant. Phone company offices have extensive battery systems, as well as backup generators, according to former CPUC

Commissioner Catherine Sandoval.

But cellphone coverage is less reliable. Cell towers need electricity to operate, but there is no requirement to have backup electrical power at cell towers. Also, cell service relies on fragile glass fiber-optic networks to route calls from the base stations to switching stations, then to customers. And because the systems are designed in a straight line, when one tower goes down, incoming calls reverse direction and bounce back.

Rural areas are especially vulnerable, with more limited networks, said RAND's Gonzales. And emergency officials are not told which towers are down or which carriers have lost service.

In the eastern Paradise neighborhoods first hit by fire, about 56 percent of the 4,272 emergency alert calls failed due to what CodeRED manufacturer OnSolve calls "operator intercept" or "timed out," meaning that the phone has been disconnected, the number changed or no longer in service, or — most likely — the network didn't find sufficient signal strength or bandwidth to make the call work, due to cell tower failure.

By 1:30 the next morning, evacuation orders were nearly futile for residents of the old logging town of Stirling City and other rural communities up on Paradise Ridge, north of Paradise. Records show that a stunning 98 percent of the phone calls made to that area to evacuate never reached a person.

"This has been a growing issue with emergency communications — fostered by transition to more and more people using cellphones and other systems that are reliant on fiber," said Sandoval.

"That's the problem with big fires: The infrastructure burns. As you lose both power and telephones, that creates failure. What you end up with is a situation that takes us back to the 1940s," she said, "where heroic responders drive up and down streets, taking their lives into their hands, using bullhorns."



Dear CPUC Commission.

On behalf of the Mendocino County Board of Supervisors, I am writing to request that the CPUC reject AT&T's application for targeted relief from its Carrier of Last Resort (COLR) legal obligations.

As a "Carrier of Last Resort" (COLR), AT&T must provide "Plain Old Telephone Service" or (POTS) landline phone service upon request to all residential and business customers within its service territory. POTS has a uniform set of minimum service standards and regulations that do not extend to new technologies that provide similar services, such as VoIP. According to the CPUC's Universal Service rules, carriers (such as AT&T) may opt out of their COLR when another COLR provides service and assumes COLR service responsibilities. AT&T's application, on the other hand, requests COLR relief for over 99% of their service territory where AT&T determines an alternative voice provider exists (VoIP, wireless, etc.) and does not request a replacement COLR. AT&T's application also requests expedited approval for future COLR relief through a CPUC Tier 1 Advice Letter process, which does not require CPUC approval. If the CPUC approves, AT&T could cancel service to its POTS customers as early as six months. Over 580,000 AT&T customers would be affected, including residents of Mendocino County, many of whom are senior citizens, live in low-income households, or reside in rural areas where other connectivity is not available to them.

Rural customers have fewer market options to choose from for quality, affordable telecommunications services. Wireless or VoIP is either an unreliable or unavailable option in many locations. POTS remains the only reliable and affordable service option for many in Mendocino County. During an emergency, such as a natural disaster or electrical power outage, customers and first responders need reliable access to 9-1-1 and 2-1-1 services, including the ability to receive alerts and notifications. POTS continues to be one of the most reliable communications tools in the safety net arsenal. COLR relief should only be

Dear CPUC President Busching Reynolds and CPUC Commissioners,

On behalf of the Town Council of the Town of Fairfax, I respectfully request that the California Public Utilities Commission (CPUC) reject AT&T's application for targeted relief from its Carrier of Last Resort (COLR) legal obligation, and also its application to relinquish its Eligible Telecommunications Carrier (ETC) designation.

As the Carrier of Last Resort, AT&T must provide Plain Old Telephone Service (POTS) or landline phone service upon request to all residential and business customers within its service territory. AT&T is requesting that the CPUC relieve it of this obligation and allow it instead to decide whether to provide telephone service, even if no other telephone provider in the area is obligated to provide service.

For some of our Town's residents (including the most vulnerable older adults and those with disabilities), especially those in locations with limited or no cell phone service, approval of AT&T's COLR application would result in them paying more for telephone service, receiving lower quality service, being required to purchase phone service as part of an expensive "bundle," or receiving no phone service at all.

If AT&T is allowed to stop being the COLR and transfer its landline service to broadband or VoIP, large numbers of Fairfax residents where cellular service is nonexistent or intermittent at best, will be deprived of a reliable means of communication. Fairfax cannot maintain a resilient, safe, connected, and prepared town without reliable landline service.

Further, if AT&T is allowed to relinquish its Eligible Telecommunications Carrier (ETC) designation, Fairfax's residents with low incomes could lose Lifeline Program access to telephone service (also including elders and the disabled). A reliable telephone service is essential for day-to-day life activities and is critical for medical emergencies, public safety, and natural disasters.

AT&T's application requests COLR relief in providing landline service for over 99% of its service territory where it determines an alternative voice provider exists (VoIP, wireless, etc.) and does not request a replacement COLR. Since the definition of "alternative voice provider exists" is based on demonstration that a carrier's footprint covers only 50% of the census block, residents in the remaining 50% are in danger of having no phone service. Additionally, AT&T's application describes the COLR requirement as an "underutilized landline telephone network," however, in households with limited cell phone coverage, landlines are far from underutilized. Landlines provide essential communications, especially in emergencies, to households without cell coverage and/or other connectivity options.

AT&T's application also requests expedited approval for future COLR relief through a CPUC Tier 1 Advice Letter process that does not require CPUC approval. If the CPUC approves, AT&T could cancel service for its POTS customers in as little as six months.

Over 580,000 AT&T customers would be affected – including many households in Fairfax – many of whom are senior citizens, live in low-income households, or reside in areas where other connectivity is not available to them, placing their lives in jeopardy in the event of an emergency. In the event of an emergency, often internet services are interrupted, which also disables VoIP services.

Fairfax opposes both AT&T applications, as they will reduce access to essential communications services for our communities while increasing costs for those still covered. For some of Fairfax's residents, who are underserved by cellular phone service, there is no substitute for landline telephone service. We strongly urge you to take into consideration the needs of those with no cellular service, those who could lose low-cost telephone services, and those living in areas, like Fairfax, of high risk for wildfire, seismic events, floods and other natural disasters, as you make your decision.

Thank you for your consideration. I strongly urge you to reject both AT&T applications regarding the COLR obligation and the ETC designation.

Urge the CPUC to reject AT&T's application to end traditional landline service in all areas until reliable broadband cellular coverage is available.

FINANCIAL IMPLICATIONS

CURRENT SITUATION AND ITS EFFECTS

California residents deserve reliable telecommunication service. The California Public Utility Commission (CPUC) must ensure that traditional landline phone service remains in place until broadband can replace it as a reliable means of communication. Many geographic areas of Berkeley do not have dependable cellular service. Removal of traditional landlines before reliable alternatives are in place, contradicts Berkeley's strategic goals of creating a resilient, safe, connected and prepared city. Landline telephone service is a lifeline for those in Berkeley who do not have reliable cell service.

AT&T submitted two applications to the California Public Utility Commission (CPUC) on March 3, 2023. One for targeted relief from its carrier of last resort obligation and certain associated tariff obligations (A23-03-003). The other, to relinquish its eligible telecommunications carrier designation (A23-03-002).

If the CPUC grants AT&T relief from being the "Carrier of Last Resort" (COLR), i.e. the only carrier legally mandated to provide service to anyone in their service territory who wants it, and therefore stops providing landline service, large numbers of residents living in Berkeley where cellular service is non-existent or unreliable will be deprived of a dependable means of communication. Reliable telephone service is essential for day-to-day life and critical for medical emergencies, public safety and natural disasters. Landlines are overwhelmingly the most reliable method of communication.

In the Berkeley Hills and other high fire risk areas throughout the state, where PG&E regularly conducts Public Safety Power Shutoffs (PSPS), traditional landlines, or Plain Old Telephone Service (POTS), are the only form of reliable communication – unless cell tower back-up generators last throughout the PSPS or disaster, and households with reliable cell service have invested in batteries or generators to keep their phones and modems operating.

Berkeley Fire Chief Dave Sprague stated that, "The loss of POTS in the region before reliable alternatives are in place creates an unacceptable degradation of public safety for California's residents following a seismic event, wildfire, or other natural disaster."

Further, if AT&T is allowed to relinquish its Eligible Telecommunications Carrier (ETC) designation, it would no longer be mandated to provide Lifeline service which ensures residents with low incomes, frequently elders and those with disabilities, can have access to telephone service.

BACKGROUND

California's telecommunications policy is founded on an ongoing commitment to universal service by assuring the continued affordability and widespread availability of high-quality telecommunications services.

The California Public Utilities Commission (CPUC) has deemed Carrier of Last Resort (COLR) obligations an important component of universal access to communications services because these obligations ensure that customers who want service, receive it.

As a COLR, AT&T has an obligation to serve all customers in its service area who request service. If the CPUC approves AT&T's application for relief of its COLR obligations, California would have no Carrier of Last Resort and residents would lose their Plain Old Telephone Service (POTS).

ENVIRONMENTAL SUSTAINABILITY AND CLIMATE IMPACTS

Elimination of Plain Old Telephone Service (POTS) could prevent safe evacuation in a natural disaster and interfere with Emergency Response. As extreme weather events increase due to climate change, access to reliable communication is critical to life and safety.

OPPOSITION TO AT&T COLR AND ETC APPLICATIONS

WHEREAS, California's telecommunications policy is founded on an ongoing commitment to universal service by assuring the continued affordability and widespread availability of high-quality telecommunications services; and

WHEREAS, The California Public Utilities Commission (CPUC) has deemed Carrier of Last Resort (COLR) obligations an important component of universal access to communications services because these obligations ensure that customers who want service, receive it; and

WHEREAS, AT&T submitted two applications to the CPUC on March 3, 2023. One for targeted relief from its carrier of last resort obligation and certain associated tariff obligations (A23-03-003); the other, to relinquish its eligible telecommunications carrier designation (A23-03-002); and

WHEREAS, If the CPUC grants AT&T relief from being the "Carrier of Last Resort" (COLR) and therefore AT&T stops providing landline service, large numbers of residents living in Berkeley where cellular service is non-existent or unreliable will be deprived of a dependable means of communication; and

WHEREAS, If the CPUC allows AT&T to relinquish its Eligible Telecommunications Carrier (ETC) designation, AT&T would no longer be mandated to provide Lifeline service which ensures residents with low incomes, frequently elders and those with disabilities, can have access to telephone service; and

WHEREAS, Reliable telephone service is essential for day-to-day life and critical for medical emergencies, public safety and natural disasters; and

WHEREAS, Berkeley Fire Chief Dave Sprague stated that "The loss of POTS in the region before reliable alternatives are in place creates an unacceptable degradation of public safety for California's residents following a seismic event, wildfire, or other natural disaster."

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Berkeley that it strongly opposes AT&T's applications A23-03-003 and A23-03-002.

BE IT FURTHER RESOLVED that the Berkeley City Council strongly urges the CPUC to reject AT&T's A23-03-003 and A23-03-002 applications.

Dear CPUC President and Commissioners,

The City of Berkeley respectfully requests that you reject AT&T's applications for targeted relief from its Carrier of Last Resort (COLR) obligation, and to relinquish its eligible telecommunications carrier (ETC) designation.

All residents deserve reliable telecommunication service. The CPUC must ensure that Plain Old Telephone Service (POTS) remains in place until broadband has achieved that standard.

If AT&T is allowed to stop being the COLR and transfer its landline service to broadband or VOIP, large numbers of Berkeley residents where cellular service is non-existent or intermittent at best, will be deprived of a reliable means of communication.

Berkeley cannot maintain a resilient, safe, connected and prepared city without reliable landline service.

Berkeley Fire Chief Dave Sprague stated that, "The loss of POTS in the region before reliable alternatives are in place creates an unacceptable degradation of public safety for California's residents following a seismic event, wildfire, or other natural disaster."

Further, if AT&T is allowed to relinquish its Eligible Telecommunications Carrier (ETC) designation, Berkeley's residents with low incomes could lose Lifeline Program access to telephone service, including elders and those with disabilities. As you know, reliable telephone service is essential for day-to-day life and critical for medical emergencies, public safety and natural disasters.

For some of Berkeley's residents, who are underserved by cellular phone service, there is no substitute for landline telephone service. We strongly urge you to take into consideration the needs of those with no cellular service, those who could lose low cost telephone services, and those living in areas of high risk to wildfire and other natural disasters, as you make your decision.

Berkeley City Council opposes AT&T landline withdrawal, supports nonprofit

The Berkeley City Council discussed agenda item 15 regarding the city's landline coverage, previously provided by AT&T, and announced an agreement with Dorothy Day House.

Amid continued calls from protestors both for and against a ceasefire resolution in Gaza, the Berkeley City Council discussed AT&T's landline coverage and approved a lease agreement for the Dorothy Day House at its regular Tuesday meeting.

The Council unanimously passed its consent calendar. Councilmember Susan Wengraf's agenda item 15, an opposition resolution to AT&T's application to dissolve its designation as a "Carrier of Last Resort," or COLR, was discussed at length during the meeting.

California law requires at least one telephone company to provide telephone service to anyone who requests it, per area. This is in place to ensure that everyone in California has "access to safe, reliable, and affordable telephone service," according to the California Public Utilities Commission, or CPUC, website.

Berkeley, like the majority of California, has AT&T as its designated COLR. The City Council's resolution also noted that landlines are the only types of "reliable communication" in the Berkeley Hills and other high fire-risk areas in California.

"If AT&T is allowed to relinquish its Eligible Telecommunications Carrier (ETC) designation, Berkeley's residents with low incomes could lose Lifeline Program access to telephone service, including elders and those with disabilities," the City Council said in a letter to CPUC. "For some of Berkeley's residents, who are underserved by cellular phone service, there is no substitute for landline telephone service."

Although many public commenters expressed support for agenda item 15, an AT&T spokesperson clarified that phone services aren't expected to be removed.

He added that the transition to newer technology and the removal of landline services was prompted by the fact that AT&T's current landline is on a copper-wire network which has parts that are no longer being made.

The council also authorized the execution of a lease agreement with Bay Area nonprofit Dorothy Day House, which provides shelter and services for unhoused people in the community. Dorothy's Closet, a retail thrift store created by Dorothy Day House and Rebuilding Together, is set to occupy a 1,400 square-foot unit inside the Telegraph-Channing Mall.

Dorothy's Closet is set to have a five-year lease on the space, starting retroactively in May of 2023. The city agreed to abate the equivalent of 18 months of revenue, or \$56,952, to account for the retroactive lease date.

Dorothy Day House executive director Robbi Montoya expressed her excitement for this Dorothy's Closet becoming an employment social enterprise, or ESE, as it will simultaneously provide free clothing, create jobs and job training opportunities.

Montoya noted that the retail space is going to fill a need in Berkeley, as most people have to choose how to allocate their limited money, either purchasing food or clothing.

Dorothy's Closet is set to have a soft opening in the coming months. Montoya said the storefront will add to Berkeley's commitment to taking care of all residents, regardless of housing status.

The values of mutually beneficial relationships have been a part of Dorothy Day Houses since its inception, Montoya noted. She hopes Dorothy's Closet will restore "dignity and some normalcy" to the unhoused community.

"We've been around for 33 years," Montoya said. " (The Dorothy Day House) was solely run by volunteers and so that manifested this really altruistic kind of atmosphere, it's kind of a fabric of our DNA."
