REMOTE PARTICIPATION UNDER AB 2449 (IF NEEDED): To consider and take action on any request from a Council Member to participate in a meeting remotely due to Just Cause or Emergency Circumstances pursuant to AB 2449 (Government Code Section 549539(f)). Assembly Bill 2302 (2024) ("AB 2302") revises rules for when members of local legislative bodies may participate in meetings remotely. Specifically, it amends the number of meetings that may be attended remotely for just cause and under emergency

circumstances and clarifies the definition of the term “meeting,” for purposes of remote attendance. AB 2302 caps the number of remote meetings a member can attend each year based on the frequency of a legislative body’s meetings: Five meetings per year for those meeting twice a month. **There was no request.**

STATEMENTS OF CONFLICTS OF INTEREST: Conflicts of interest may arise in situations where a public official deliberating towards a decision, has an actual or potential financial interest in the matter before the Council. A potential conflict of interest is one that could be to the private financial benefit of a Councilmember, a relative or a business with which the Councilmember is associated. A Councilmember must publicly announce potential and actual conflicts of interest, and, in the case of actual conflict of interest, must refrain from participating in debate on the issue or from voting on the issue and must remove themselves from the dais. **Mayor Zollman stated he would be recusing himself from Item Number 10 as he sits on the Board.**

LOOKS LIKE EVERY ONE OF MY COLLEAGUES IS BACK, WE'RE GOING TO DO A TECH CHECK. CODY, ARE WE, ARE WE OKAY? OKAY. CODY, ARE WE ALL GOOD? ALL RIGHT. GOOD. CODY, TECH CHECK IS GOOD, MARY, ARE WE OKAY? WE ARE RESUMING AND WE'RE GOING TO CALL AGENDA ITEM NUMBER EIGHT, WHICH IS ITEM CONTINUED FROM JULY 1st, 25. CITY COUNCIL MEETING, DISCUSSION OF AMENDMENTS, AGENDA REVIEW COMMITTEE PROTOCOL, AUTHORITY TO CANCEL CITY COUNCIL MEETINGS, THE REQUESTER IS COUNCILMEMBER HINTON, AND THE FISCAL IMPACT, THERE IS NO FISCAL IMPACT WITH THE APPROVAL OF THIS ITEM. COUNCILMEMBER HINTON.

SURE. IN ADDITION TO PAGE ONE IS THE REQUEST TO CHANGE THE LANGUAGE. I THINK IT'S IRONIC THAT THIS IS THE MEETING THAT WE WOULDN'T HAVE HAD, HAD THIS ISSUE NOT COME UP. AND OBVIOUSLY WE HAVE A FULL AGENDA TONIGHT AND WE KEEP HAVING A FULL AGENDA, AND I BELIEVE THAT IT CAME UP IN AGENDA REVIEW, AND I DON'T BELIEVE THAT THAT'S WHERE CANCELED MEETINGS SHOULD TAKE PLACE. BECAUSE, OCCASIONALLY, THERE'S PEOPLE THAT ARE GOING TO BE ABSENT, AND THEY MIGHT WANT TO MOVE THE MEETING AROUND, AND THIS SHOULD BE DECIDED BY THE FULL COUNCIL. AND WE DID DECIDE THIS ISSUE AT THE BEGINNING OF THE YEAR AND APPROVE OUR CALENDAR. SO, A LOT OF THESE PROTOCOLS WERE CREATED, AND I DIDN'T REALLY SEE THE IMPACT, AND I DO BELIEVE WE SHOULD REVIEW PROTOCOLS OCCASIONALLY, AS THINGS DO COME UP, THAT'S WHY I REQUESTED THIS AGENDA ITEM. WITHIN THIS AGENDA ITEM, ALSO, I HAD A COUPLE OTHER THINGS TO BE BROUGHT UP. ON PAGE THREE, IT SAYS, OR SHALL BE SCHEDULED FOR CANCELLATION UPON APPROVAL OF AGENDA REVIEW COMMITTEE. REGULAR MEETINGS. SO, IT'S LISTED THERE IN OUR PROTOCOLS AGAIN, I WOULD ALSO LIKE TO TALK TONIGHT ABOUT A CLOSED SESSION, IT LOOKS LIKE THE WAY I READ THIS I WOULD LIKE THE ATTORNEY'S ADVICE, I UNDERSTOOD THAT ONLY THE ATTORNEY OR THE MAYOR COULD CALL A CLOSED SESSION. BUT, THE ATTORNEY IS NOT MENTIONED, UNLESS I MISSED SOMETHING ON PAGE FOUR. AND I WOULD LIKE TO DISCUSS THAT ALSO BEING ADDED, LIKE IT IN ON THE PROTOCOLS THAT A MAJORITY OF MEMBERS OF THE COUNCIL COULD CALL CLOSED SESSION. AND THEN, I BELIEVE WE'VE HAD CONFUSION ABOUT A PROTOCOL, IF IT'S OKAY TO BRING THIS UP, ON ITEM EIGHT, WHICH IS, WHEN MOTIONS ARE MADE AND SECONDED, THEN THE PROCEEDS

WHILE THE AGENDA REPORT ONLY LISTS ARE THAT ONE THING, THE AGENDA IS THE TITLE AND RECOMMENDATION ABROAD TO DISCUSS CITY COUNCIL PROTOCOLS, RULES FOR COMICS OF ITS MEETINGS, CIVIL CITY BUSINESS, SO YOU CAN DISCUSS THINGS WITHIN THOSE OTHER PROTOCOLS AS WELL.

OKAY. I WOULD LIKE TO ASK COUNCILMEMBER HINTON TO WALK US THROUGH EXACTLY THE ADDITIONAL ITEMS THAT YOU WOULD LIKE US TO LOOK LIKE, PAGE NUMBER AND PARAGRAPH, ET CETERA, SO WE CAN UNDERSTAND.

SURE, AND IT CAME UP ONCE I DID THE FULL REVIEW, SO, AGAIN, REVIEWING THE FIRST PART IS AT THE BOTTOM OF NUMBER EIGHT,

PAGE NUMBER?

PAGE ONE, THAT'S THE ORIGINAL AGENDA ITEM. IT'S CALLED OUT. THEN, YOU MAY NOTE THAT, LET ME SEE, HERE. THIS ALLOWS I BELIEVE, ANYWAY, THAT'S THE FIRST PART. NUMBER TWO, IS PAGE THREE, IF YOU LOOK AT THE LAST LINE IN THE REGULAR MEETINGS, IT SAYS, THE REGULAR MEETINGS ARE HELD, AS WE KNOW THEY'RE HELD, TWICE A MONTH, OR, RIGHT HERE AGAIN, SHALL BE SCHEDULED FOR CANCELLATION UPON APPROVAL OF AGENDA REVIEW COMMITTEE.

SO ARE YOU SUGGESTING WE STRIKE THAT?

I AM SUGGESTING THAT, WE STRIKE THAT, ANY CANCELLATION MEETINGS THAT AREN'T AN EMERGENCY SHOULD BE ADJUSTED ON THE CALENDAR BY THE FULL COUNCIL.

DO YOU HAVE SPECIFIC LANGUAGE FOR THAT OR YOU JUST STRIKING?

I THINK WE COULD JUST STRIKE IT. OR THE SPECIFIC LANGUAGE COULD BE TAKEN FROM THIS FIRST ONE, WHEN A MAJORITY OF MEMBERS HAVE AGREED, OR SOMETHING. BUT I THINK WE KNOW WITH THE MAJORITY, COULD CHANGE THE MEETING.

THEN ON THE VERY BOTTOM PARAGRAPH OF PAGE FOUR, THE WAY I READ IT, I ALWAYS UNDERSTOOD CLOSED SESSIONS COULD BE CALLED BY BOTH THE MAYOR AND OUR CITY ATTORNEY, I THINK I LEARNED THAT FROM THE CITY ATTORNEY, ACTUALLY, BUT WHEN I READ THIS I DIDN'T SEE THAT IT COULD BE CALLED BY THE CITY ATTORNEY, AND I ALSO FEEL LIKE A CLOSED SESSION SHOULD BE ABLE TO BE CALLED BY THE MAJORITY OF COUNCILMEMBERS.

CAN I ADDRESS?

GO FOR IT, SO, THAT'S ACTUALLY IN A DIFFERENT POLICY, THAT'S IN POLICY NUMBER SIX. WHICH IS NOT IN THIS POLICY WHERE IT SAYS CLOSED SESSIONS MAY BE SCHEDULED BY THE AGENDA REVIEW COMMITTEE IN ACCORDANCE WITH

POLICY, ALTERNATELY THE CITY ATTORNEY MAY SCHEDULE CLOSED SESSION. SO, THE LANGUAGE IS IN A DIFFERENT POLICY.

THE LANGUAGE FOR THE CITY ATTORNEY.

CORRECT. SO, I GUESS MY QUESTION IS, WHY, I THINK THAT THE MAJORITY OF COUNCIL SHOULD BE ABLE TO CALL FOR A CLOSED SESSION AS WELL. I'M NOT SURE WHY IT NEEDS TO BE ONLY THE MAYOR, OR ONLY THE CITY ATTORNEY. AND BY THE WAY, IS EXCLUDING THE CITY MANAGER. SO, I'M INTERESTED IN TALKING ABOUT THAT. I THINK IT'S VERY LIMITING. AND, THESE POLICIES WERE CREATED BY THE MAYOR AND THE VICE MAYOR AND PUT FORTH AND CURRENTLY THE POLICY PROTOCOL SUBCOMMITTEE IS ALSO THE CURRENT MAYOR AND VICE MAYOR. TO BE FAIR, I JUST DON'T THINK, AS NOW I'M READING THEM THAT THEY'VE ACTUALLY IMPACTED US FOR A WHILE. SO, AND THEN, LASTLY, THE LAST ITEM I'D LIKE TO BRING UP, IS ON PAGE NINE, IT'S UNDER TYPES OF MOTIONS. AND IT SAYS WHEN THE FOLLOWING MOTIONS ARE MADE AND SECONDED, THE PRECEDING OFFICER, WHICH IS USUALLY THE MAYOR, MUST IMMEDIATELY CALL FOR A VOTE OF THE BODY WITHOUT DEBATE ON THE MOTION. SO, WE HAVE IN PRACTICE, I THINK STRUGGLED WITH THIS A BIT. I, MYSELF, HAVE FOLLOWED THESE NEW PROTOCOLS, AND THEN OFFERED HIM A BECAUSE I CAN OFFER AN ALTERNATE MOTION, WHICH THEN GOES FIRST, BEFORE THE MOTION. BUT IT REALLY, THE WAY THIS IS WORDED, THE WAY I UNDERSTAND THIS IS, IF SOMEBODY JUST OFFERS A MOTION IN SOMEBODY ELSE SECONDS AND SOMEBODY ELSE OVER HERE IS WAITING TO TRY AND DISCUSS IT, THEN WE'RE REALLY NOT SUPPOSED TO GET CALLED ON. WE'RE MOVING FORWARD TOWARDS THE MOTION AND THEN A VOTE.

I JUST WANT TO ASK A QUESTION, TOO, I GUESS I'M A LITTLE CONFUSED. THE AGENDA ITEM NUMBER EIGHT, IS IN REFERENCE TO THE POLICY, SEVEN. ABOUT THE CANCELLATION OF MEETINGS. SO, ALEX, IS POLICY SEVEN THE ENTIRE PAGE NUMBERS FROM ONE TO 15? I'M CONFUSED ABOUT THE NOTICING OF THIS.

YES, POLICY SEVEN IS, I DON'T KNOW HOW LONG EXACTLY, BUT IT IS OVER FIVE PAGES LONG.

OKAY. COULD, OKAY. SO, THERE YOU GO.

13 PLATE PAGES LONG, MARY TELLS ME.

COUNCILMEMBER MAURER?

IT LOOKS TO ME LIKE THESE ARE ADDRESSING TYPES OF MOTIONS, NOT JUST A GENERAL MOTION. SO I DON'T FULLY UNDERSTAND THAT.

CAN I ASK THE QUESTION? I HAVE UNDERSTOOD, AND WE HAVE STRUGGLED WITH THIS, SO I'D LIKE TO JUST GET IT CORRECTED, IF SOMEBODY MOVES TOWARDS A MOTION AND SOMEBODY SECONDS, MANY TIMES WE'VE SEEN NOBODIES FAULT SOMEBODY IS LOOKING ONE DIRECTION, WE DON'T HAVE A GOOD LIGHT SYSTEM, THEN ALL OF A SUDDEN THE WAY I READ THIS IS THEN, I'VE BEEN DIRECTED THAT IT'S HARD FOR US TO CONTINUE TO MAKE A COMMENT, THAT'S THE WAY I'M READING IT AND THAT IN PRACTICE HOW WE STRUGGLED WITH THIS, AM I CORRECT?

UNDER OUR POLICIES, CERTAIN MOTIONS, THE TYPES OF MOTIONS, MOTION TO ADJOURN, MOTION TO RECESS, SO ON AND SO FORTH, THOSE REQUIRE IMMEDIATE VOTES. UNDER POLICY. NOT ALL OF MOTIONS REQUIRE OUR IMMEDIATE VOTE, CERTAINLY IF THE COUNCIL WANTED FOR SIMPLICITY WE COULD JUST TAKE OUT THAT REQUIREMENT THAT THERE BE IMMEDIATE VOTES FOR ANY MOTION, SO THAT COUNCILMEMBERS MAY ALWAYS OFFER THEIR COMMENTS BEFORE A VOTE. IF THAT'S THE WILL OF THE COUNCIL.

I WOULD APPRECIATE THAT. I THINK. WE DON'T ALWAYS SEE, WE CAN'T, YOU KNOW? I DON'T UNDERSTAND IT.

THERE IS NO REASON THE COUNCIL CAN'T MODIFY THEM AS IT WANTS.

I APPRECIATE THIS BECAUSE I ALWAYS ASSUMED THAT YOU COULD RUSH MOTION, SECOND, BUT I LEARNED EARLY ON THAT'S NOT A GOOD THING. BECAUSE IT'S NOT VERY COURTEOUS, JUST BECAUSE IT SECONDED YOU DON'T NECESSARILY HAVE TO GET RIGHT TO THE BOAT YOU CAN HAVE TO CONTINUED DISCUSSIONS OR ENTERTAIN PEOPLE,, RIGHT?

SO I'D JUST LIKE TO CLEAN IT UP, I FIGURED SINCE WE WERE GOING THROUGH THIS I LIKE TO CLEAN UP A COUPLE OF THESE THINGS SO THAT WE'RE STRAIGHT ON IT, SOMETIMES IT IS CONFUSING APPEAR, AND I JUST WANT IT TO BE MORE INCLUSIVE.

OKAY. SO, WHAT, SHOULD WE JUST TAKE ABOUT OR SEND IT BACK TO STAFF?

WHAT I WOULD RECOMMEND, IF WE CAN GET CONSENSUS, WE GO ONE AT A TIME THEN WE'LL MAKE THOSE CHANGES AND BRING IT BACK AND PUT IT ON CONSENT FOR YOU TO ADOPT.

THAT WOULD BE GOOD. I NEED TO SEE IT ALL BEING PROPOSED, I CAN'T REALLY, IT'S HARD FOR ME TO CONCEPTUALIZE WORDING. YEAH. IS THAT GOOD? I'M SORRY.

YEAH, PUBLIC COMMENT AND THEN,

YEAH, ARE WE ALL GOOD BEFORE WE GO TO PUBLIC COMMENT? OKAY, THANK YOU. ARE WE GOOD BEFORE WE GO TO PUBLIC COMMENT? MARY, PUBLIC COMMENT?

THANK YOU, MAYOR, THIS IS FOR AGENDA ITEM REGARDING THE PROTOCOLS AND COUNCIL MEETINGS, IF YOU'D LIKE TO MAKE A PUBLIC COMMENT I WILL GO TO CHAMBERS FIRST. SEEING THAT I WILL GO OUT TO ZOOM, IF YOU WOULD LIKE TO MAKE A PUBLIC COMMENT ON THIS ITEM, PLEASE RAISE YOUR HAND VIRTUALLY, KYLE, CAN YOU UNMUTE YOURSELF, PLEASE YOU MARK THANK YOU, CAN YOU SEE THE TIMER?

YES, I CAN.

GO AHEAD, PLEASE.

I THINK WATCHING THIS COUNCIL OVER THE LAST FIVE YEARS AND TO SEE THE CHANGES TO PROTOCOLS ALONG THE WAY, I WOULD BE INTERESTED IN HAVING THIS COUNCIL DO A LITTLE BIT OF RESEARCH IN THAT SPACE. IT APPEARS TO ME THAT SOMETIMES CHANGES IN PROTOCOLS ARE BEING DONE TO SUIT INDIVIDUAL COUNCILMEMBERS, I'VE SEEN CHANGES TO PROTOCOLS AROUND PUBLIC COMMENT, I'VE SEEN CHANGES TO PROTOCOLS AROUND THE AGENDA REVIEW, AND IT'S, IT'S CONCERNING TO ME, THE PACE AT WHICH PROTOCOLS ARE CHANGING ON COUNCIL OVER THE LAST FIVE YEARS, AND HOW, MAYBE, THESE PROTOCOLS ARE NOT IN ALIGNMENT WITH WHAT OTHER CITIES MAY BE DOING. SO, I WOULD JUST SUGGEST, ESPECIALLY IF YOU'RE GOING TO DO SOMETHING LIKE A RADICAL CHANGE, DEPARTING FROM ROBERTS RULES REGARDING MOTIONS SECONDS AND BOATS, WE'VE SEEN SOME PRETTY DRAMATIC CHAOS COMING FROM THE ELECTION OF MAYORS IN THIS COUNCIL , THAT ARE DIRECTLY RELATED TO POLITICIZING THE MOTION, SECOND, CALL TO BOAT PROCESS. SO, AGAIN, CONCERNED ABOUT PROTOCOLS CHANGING FOR PARTICULAR INDIVIDUAL, COUNCILMEMBERS FAVOR, CHANGES TO MANY OF THESE PROTOCOLS THAT MAY BE OUTSIDE OF THE NORM OF THE VOLUME OF CHANGES IN A SHORT PERIOD OF TIME, AND WOULD INVESTIGATE FURTHER BEFORE YOU MAKE LARGE-SCALE DECISIONS.

THANK YOU, KYLE, FOR YOUR PUBLIC COMMENT, NEXT I WILL COME BACK INTO CHAMBERS, IF THERE'S ANYONE IN CHAMBERS THAT WOULD LIKE TO MAKE A

PUBLIC COMMENT, SEEING NONE, I WILL GO BACK TO ZOOM, IF THERE IS ANYONE IN ZOOM THAT WOULD LIKE TO MAKE A PUBLIC COMMENT ON THE ITEM, PLEASE RAISE YOUR HAND VIRTUALLY, SEEING NONE, PUBLIC COMMENT IS CLOSED.

I WILL RESPOND TO THE COMMENTOR IN THE FACT THAT WHEN THE PROTOCOLS WERE INITIALLY APPROVED BY ALL OF US, I'D HAVE TO SAY MARY DID ALL THE WORK, I REMEMBER THE AGENDA REPORTS, SHE WENT AND LOOKED AT CLOVERDALE, SHE WENT ALL OVER THE STATE, COME FORWARD WITH THE DIFFERENT PROSPECTS THAT WE COULD GO THROUGH. SO, I WANT TO PUT IT OUT TO THE PUBLIC THAT WE DIDN'T WILLY-NILLY COME UP WITH PROTOCOLS, BUT I ALSO APPRECIATE COUNCILMEMBER HINTON THAT, YOU PASS THINGS AND THEN IN THEORY IT CAN GO DIFFERENT WAYS, AND IT'S ALWAYS GOOD TO EXAMINE THINGS. SO, ARE THERE OTHER DISCUSSIONS BEFORE WE END OUR MOTION? COUNCILMEMBER MAURER?

I WOULD SUPPORT THE FIRST EDITOR WAS PROPOSED IN THE STAFF REPORT, I WOULD SUPPORT THE SECOND EDIT ON PAGE THREE, THE LAST LINE, REGARDING STRIKE THAT, STARTING WITH THE WORD OR COMMENTS PAGE THREE, AND FOR THE LAST ONE I THINK IT'S MORE COMPLICATED. IS THERE STILL AN AD HOC POLICY COMMITTEE, AND IF THERE IS I'D LIKE TO SEND IT BACK AND MAYBE COUNCILMEMBER HINTON CAN WORK, ARE YOU ON IT? YOU'RE NOT?

AND THERE'S TWO MORE ITEMS IF WE'RE GOING TO SEND IT BACK.

I WOULD RECOMMEND THAT THOSE GET SENT BACK AND RUN BY THE CITY ATTORNEY SO THAT WE HAVE THE CLEAR, LIKE WE DO ON THE STAFF REPORT, CLEAR EDITS. THAT'S JUST MY SUGGESTION.

I MEAN, I'LL WEIGH IN, CLEAR EDITS I THINK WOULD BE GOOD, HONESTLY I THOUGHT WE WERE GOING THROUGH THE FIRST TWO, I DIDN'T KNOW WE WERE GOING THROUGH ALL THE REST OF THIS 15 PAGE POLICY. I MISSED THAT. I WOULD LIKE TO HAVE IT SENT BACK, TOO, FOR CLEAR EDITS, STRIKEOUT, SUGGESTED WORDING, ALL OF THAT.

IF WE CAN RUN THROUGH THE THREE, FOUR ITEMS THAT HAVE BEEN RAISED, AND GET THUMBS UP OR THUMBS DOWN IF YOU WANT US TO TAKE THEM, WE'LL TAKE DIRECTION AND COME BACK WITH A REDLINE, SO IT'S CLEAR TO THE COUNCIL.

YOU WANT ME TO STATE THEM AND EVERYBODY CAN THUMB UP, THUMBS DOWN? OKAY, SO THE ONE IS, AS COUNCILMEMBER MAURER STATED ON PAGE ONE, THAT'S THE LANGUAGE PRESENTED HERE, I THINK I'M FINE WITH AS IT READS TONIGHT. OKAY.

SURE.

ITEM TWO IS ON PAGE THREE, COUNCILMEMBER MAURER SUGGESTED, AND I SUGGEST JUST STRIKING, STARTING AT THE, OR SHALL BE SCHEDULED BY AGENDA REVIEW. THAT'S CONSISTENT WITH THE STAFF REPORT. ITEM TWO. ITEM THREE, TO GO BACK TO THE PROTOCOLS COMMITTEE, WOULD BE AT THE BOTTOM OF PAGE FOUR, AND THAT'S REGARDING WHO CAN CALL A CLOSED SESSION. I THINK IT'S CONFUSING, AND RIGHT NOW IT'S ONLY THE MAYOR OR THE CITY ATTORNEY. AND I THINK THAT THAT COULD BE EXPANDED. AND SHOULD BE EXPANDED TO POSSIBLY INCLUDE THE MAJORITY OF COUNCIL, OR, TO SEND THAT ONE BACK TO THE COMMITTEE, YEAH.

THE FOURTH ITEM IS THIS, HOW WE'VE STUMBLERED OVER EACH OTHER IN PAGE NINE, WHICH SAYS, WHEN MOTIONS ARE MADE AND SECONDED, THE PRECEDING OFFICER MUST IMMEDIATELY CALL FOR A VOTE WITHOUT FURTHER DEBATE. LET ME READ IT, OR COMMENTS. SO THAT, I KNOW WE'VE STRUGGLED ON IT, SO I'D LIKE IT CLARIFIED.

SURE, I'M HAPPY.

SEND IT BACK.

YEAH, SEND IT BACK. THOSE ARE MY ITEMS.

OKAY, MARY, ARE YOU CLEAR ON WHAT WE'RE DOING?

CAN I MAKE ONE SUGGESTION BEFORE YOU MAKE A MOTION?

IT'S NOT THAT, IT'S, I WOULD LIKE TO BRING BACK THE AGENDA ITEM, I'M SORRY, LET ME MAKE SURE I HAVE THE POLICY RIGHT. COUNCIL POLICY NUMBER SIX, WHICH ADDRESSES THE CLOSED SESSION. THE COUNCIL POLICY THAT WE'RE LOOKING AT RIGHT NOW IS JUST THE PROCESS OF THE CLOSED SESSION. TWO EXTENDED CAN A LATER HOUR, IT DOESN'T SAY WE CAN START IT. THE OTHER PROTOCOL OR POLICY DOES STATE IT. SO, WE SHOULD BRING THEM BOTH BACK.

I THINK YOU SHOULD, THOUGH STILL ONLY SAY THAT TWO PEOPLE ARE ALLOWED TO CALL CLOSED SESSION.

I WOULD LIKE AS PART OF THE MOTION THAT THAT POLICY WOULD COME BACK AS WELL.

SURE.

OKAY, YEAH. SURE. OKAY. DOES SOMEONE NEED TO MAKE A MOTION? IF NOT, CAN YOU STATE IT AND SOMEBODY CAN MOVE IT? WHAT YOU THINK?

I DON'T THINK WE NEED A FORMAL MOTION OF THIS, COUNCIL CONSENSUS TO RETURN THESE UP ON THE DISCUSSION OF THE CHANGES WE JUST DISCUSSED.

SURE, OKAY, THERE WE GO. THEN WE ARE MOVING ALONG. SO NOW WE'RE ON TO AGENDA ITEM NUMBER NINE, APPROVAL OF ECONOMIC GARDENING PROGRAM EVENT, THE CITY OF SEBASTOPOL IS PROPOSING TO HOST AN ECONOMIC GARDENING PROGRAM EVENT AIMED AT SUPPORTING THE GROWTH OF HOMEGROWN BUSINESSES. THIS IS BEEN REQUESTED BY COUNCILMEMBER CARTER TO RESPONSIBLE DEPARTMENT IS THE COMMUNITY DEVELOPMENT DIRECTOR, FISCAL IMPACT, \$3000 HAS BEEN APPROVED THE FISCAL YEAR 25-26 CITY BUDGET FOR THIS EVENT. AND THE RESPONSIBLE PARTY IS COMMUNITY DEVELOPMENT DIRECTOR WHICH I GUESS WE ARE GOING TO OUR INTERIM CITY MANAGER.

YES, SO THIS, AGENDA ITEM IS BROUGHT FORWARD BY COUNCILMEMBER CARTER, WHO'S BEEN THE EXPERT, I KNOW HE WAS WORKING WITH THE COMMUNITY DIRECTOR WHO IS OUT RIGHT NOW, I'M GOING TO ASK COUNCILMEMBER CARTER IF HE WANTS TO PRESENT HIS AGENDA ITEM AS TO WHAT HE'S REQUESTING AND I BELIEVE HE SPOKE WITH THE CHAMBER ON THIS AS WELL IN THE DOWNTOWN IF I'M NOT MISTAKEN.

YEAH. BASICALLY THIS IS TO BEGIN A RELATIONSHIP WITH OUR BUSINESS COMMUNITY THROUGH A WORKSHOP. SCENARIO. WHERE WE GATHER AT THE LOCAL BUSINESSES THAT MAY FEEL A LITTLE BIT OUT OF TOUCH WITH US, SO THAT WE CAN ORGANIZE THROUGH A FACILITATOR WORKSHOP HOW THE CITY CAN BEST HELP THE BUSINESS COMMUNITY. FOR INSTANCE, WE HAVE THESE TWO LOVELY PEOPLE FROM THE CITY COME TO US TONIGHT, WITH SOME WAYS TO IMPROVE THE DOWNTOWN AND WE WANT TO EMPOWER THAT. WE NEED TO FACILITATE THAT, BY HAVING A VENUE WHERE OTHER PEOPLE CAN EXPRESS THEIR KNOWLEDGE, WISDOM, FEELINGS, WHAT, WHAT'S INHIBITING THEM, HOW THE CITY COUNCIL CAN BEST PROVIDE A WAY FOR THEM TO MOVE ON. WHAT THIS SPECIFICALLY DOES IS, THIS IS A PROGRAM THAT HAS PROVEN LEGS, AND WORKS SINCE THE LATE 90s, TO SUPPORT BUSINESSES THAT ALREADY EXIST. SO WE DON'T HAVE TO GO OUT FISHING FOR NEW BUSINESSES, ADDING TAXES OR WHATEVER TO GET SOME BRAND-NEW BUSINESSES IN THAT WE MAY OR MAY NOT DO THE CITY WELL, BUT MOSTLY FOCUS ON THE BUSINESSES THAT WE ALREADY HAVE AND

PROVIDE THEM RESOURCES AND EDUCATION, MENTORSHIP, DATA, AND SUPPLY THEM A VENUE FOR THEM TO COMMUNICATE, LIKE, OUR WATER BILL IS TOO HIGH, THESE KINDS OF THINGS.

YES, THANK YOU FOR THE PRESENTATION. AND THANK YOU FOR BRINGING IT FORWARD, I THINK IT'S WONDERFUL AND WHEN I WAS ON THE CITY SITE, THIS HAS GOT A HUGE PROVEN TRACK RECORD BACK TO THE 1970S. IT WAS, IT'S BEEN AROUND FOR A WHILE, AND THE DATA IS THERE TO SUBSTANTIATE IT ALL, SO I LOVE IT. IT'S REALLY GREAT, TIED IN WITH OUR EARLIER INFORMATIONAL PRESENTATION. WONDERFUL PEOPLE FROM OUR CHAMBER, SO YES, I LOVE IT, THANK YOU FOR BRINGING IT FORWARD. COUNCILMEMBER MAURER.

I'M WONDERING, HOW IS THIS DIFFERENT FROM THE MAIN STREET AMERICA PROGRAM? AND HOW WILL, HOW DOES THIS IMPACT OUR STAFF? BECAUSE RIGHT NOW, WE HAVE ONLY A PART-TIME COMMUNITY DEVELOPMENT PERSON. HOW DOES IT IMPACT STAFF?

AGAIN, SO, THIS, I'M GOING TO VOLUNTEER MY OWN PERSONAL TIME TO HELP FACILITATE THIS, BUT, FUNDAMENTALLY, I DON'T, I'M NOT REALLY POSITIVE WHERE OUR STAFF SITS AS FAR AS COMMUNITY DEVELOPMENT BUT MAYBE WE COULD PUT THIS FURTHER OUT INTO THE FALL. BUT FUNDAMENTALLY IT SHOULDN'T REQUIRE TOO MUCH STAFF TIME, AS THIS IS MOSTLY JUST A FEEDBACK GATHERING MECHANISM. WITH THE CITY. WITH THE CITY'S BUSINESSES. RUPEE YOUR SECOND QUESTION?

HOW ARE YOU GOING TO GATHER THAT FEEDBACK? IS IT GOING TO BE AN ACTUAL EVENT IN A SPACE? SURVEY ?

SO, AS WE PUT FORWARD IN THE BUDGET, AND THE BRAINSTORMING SESSION, THIS IS ACTUALLY ONE MEETING, AND THE \$3000 COVERS THE VENUE, ANY ANCILLARY THINGS, HOPEFULLY IT CAN COST LESS THAN \$3000, BUT FUNDAMENTALLY THIS IS FACILITATING A WORKSHOP WITH THE BUSINESSES THAT EXIST, AND THAT'S NOT WHAT MAIN STREET AMERICA IS, MAIN STREET AMERICA IS A RESOURCE, AND THIS IS THE VENUE FROM WHICH THE CITY STARTS SUPPORTING BUSINESSES. AND EVENTUALLY, EVENTUALLY, THE GOAL MIGHT BE TO PROVIDE, THIS WOULD BE THE MECHANISM TO PROVIDE US, BRANDS FOR A NEW SCIENCE, THE DOWNTOWN SIGNAGE MAY NOT BE THE GREATEST OR SOME BUSINESSES MAY NEED SOME HELP, WITH THEIR STORM FRONTS OR SOMEONE LIKE THAT, THE CITY CAN USE THIS AS AN OPPORTUNITY TO SAY, BUT APPROPRIATE \$3000 SO WE CAN HELP WITH ONE BUSINESSES SIGN OR SOMETHING THAT THEY MIGHT NEED. WE DON'T KNOW WHAT THAT IS UNTIL WE WORKSHOP IT.

SO FOR EXAMPLE YOU MIGHT HOST AN INITIAL EVENT HERE, AT THE YOUTH ANNEX, AND INVITE THE BUSINESSES TO COME. OKAY.

AND, WHO WOULD FACILITATE IT?

WE'RE GOING TO WORK WITH THE CHAMBER OF COMMERCE, SO THEY'RE GOING TO DO HALF OF IT, AT LEAST HALF OF IT, AS FAR AS THE CITY GOES, THAT'S A LITTLE BIT TBD. NOT TOTALLY SURE, BUT I'M WILLING TO VOLUNTEER MYSELF.

I DO THINK ONCE WE SCHEDULE THIS EVENT, THAT WORKING WITH THE CHAMBER, I AGREE, I'M GOING TO DISAGREE WITH COUNCILMEMBER CARTER FOR A SECOND, I THINK IT GOES WITH MAIN STREET, BUT I DON'T HAVE ENOUGH INFORMATION ABOUT THE MAIN STREET PROGRAM TO KNOW. SO, THERE IS IS MORE ABOUT THE COLLABORATION OF EVENTS AND THINGS, IT SOUNDS LIKE, THIS IS WHAT WE'RE TRYING TO DELVE INTO HELPING BUSINESSES AND WHAT THEY WANT TO SEE FOR SEBASTOPOL, HOW TO ENCOURAGE LOCAL BUSINESSES, WHAT OUR LOCAL BUSINESSES NEED TO SUSTAIN AS WELL AS BRINGING IN THE TYPES OF

BUSINESSES THAT WE WANT. THERE'S A LOT OF COMMUNITY MEMBERS THAT ARE EXPERTS IN THIS FACILITATION, SO I THINK WE WOULD FIND SOMETHING WITHIN THE COMMUNITY THAT KNOWS THE COMMUNITY AND NOT HAVING TO FACILITATE THIS WORKSHOP. STAFF TIME IS GOING TO BE MORE ABOUT TO SET UP THE VENUE, GET THE INVITATIONS OUT, FOR THE BUSINESSES AND THINGS LIKE THAT, I DON'T ANTICIPATE A HUGE AMOUNT OF STAFF TIME TO DO THIS, AND I WOULD NOT HAVE OUR CONSULTANTS DO THAT, THAT WOULD BE SOMETHING WE WOULD DO IT STAFF LEVEL.

GREAT. OTHER QUESTIONS? LOOKING TO MY RIGHT, THOUGH, BACK TO COUNCILMEMBER MAURER.

WHICH DEPARTMENT WITH THIS BALL TO, THEN?

IT WOULD FALL TO THE COMMUNITY DEVELOPMENT, BUT, SINCE WE HAVE A CONSULTANT, THAT DEPARTMENT IS NOW FALLING UNDER ME RIGHT NOW SO WE ARE WORKING WITH THE COMMUNITY DEVELOPMENT FOR ALL OF IT.

ALL THE SCHEDULING WOULD FALL TO YOU.

WE HAVE STAFF. THERE IS ADMINISTERED OF ASSESSMENT THAT I COULD USE TO DO THINGS LIKE THAT, SO THEY WOULD BE ABLE TO DO THAT AS WELL. OKAY.

NO OTHER QUESTIONS? I GUESS WE'RE GOING OUT TO PUBLIC COMMENT.

THIS IS PUBLIC COMMENT ON THE ECONOMIC GARDENING PROGRAMMING EVENT, IF YOU'D LIKE TO MAKE A PUBLIC COMMENT I WILL GO TO CHAMBERS FIRST.

SEEING NONE I WILL GO OUT TO ZOOM, ROBERT, CAN YOU UNMUTE YOURSELF, PLEASE? THANK YOU. CAN YOU SEE THE TIMER? GO AHEAD, PLEASE.

I'M OFFERING FREE ADVICE, I THINK WHEN THIS WAS THOUGHT OF BY PHIL, WE HAVEN'T HEARD ANYTHING ABOUT THE CHAMBER'S PROPOSAL. IT DOES SOUND TO ME LIKE THEY SHOULD BE PART OF THE SAME INITIATIVE. TO MAKE THE CITY BETTER, AND MAYBE PHIL AND MARY SHOULD GO BACK AND HAVE A MEETING WITH THE CHAMBER PEOPLE THAT WERE PRESENTING EARLIER, AND DISCUSSED HOW CAN THIS BE PUT TOGETHER IN ONE PACKAGE THAT HAS A PLANETS MOVING US FORWARD? THAT'S MY THOUGHT, THANKS.

THANK YOU, ROBERT, FOR YOUR PUBLIC COMMENT, I WILL COMMIT TO CHAMBERS, IF THERE'S ANYONE IN CHAMBERS THAT WOULD LIKE TO MAKE A PUBLIC COMMENT, I WILL GO BACK OUT TO ZOOM IF THERE'S ANYONE ON ZOOM THAT CAN MAKE A PUBLIC COMMENT, PLEASE RAISE YOUR HAND VIRTUALLY. SEEING NONE, PUBLIC COMMENT IS FLOAT CLOSE ON THIS ITEM.

BRINGING IT BACK TO THE DAIS FOR FURTHER DISCUSSION AND/OR MOTION, COUNCILMEMBER CARTER.

I JUST WANT TO SPEAK TO OUR CALLER, WHEN THE CHAMBER AND THE DOWNTOWN ASSOCIATION PRESENTED TODAY, MAIN STREET.ORG OR WHATEVER, THIS CAN FIT IN PERFECTLY, THESE, THEY'RE THE SAME THING.

COUNCILMEMBER HINTON?

WHEN WE APPROVE THIS IN THE BUDGET WE DIDN'T APPROVE A TIME OF YEAR, AND FOR ME, I REALLY QUESTIONED THAT FALL IS THE RIGHT TIME FOR THIS WITHIN OUR FISCAL BUDGET. CURRENTLY WE HAVE OUR ECONOMIC DEVELOPMENT PERSON OUT, WE HAVE CONSULTANTS IN THOSE ROLES, WE HAVE AN INTERIM CITY MANAGER, WE HAVE A CHAMBER PRESENTATION WE HEARD TONIGHT ABOUT MAIN STREET, THAT THEY'RE GOING TO GO AHEAD AND MOVE FORWARD ON THAT, WHICH COULD HELP COORDINATE TOGETHER WITH THIS. I'D REALLY LIKE TO SEE THIS PROJECT MOVED TO SPRING. WHEN WE HAVE OUR ECONOMIC DEVELOPMENT PERSON BACK, AND PROBABLY, I'M GLAD MARY IS DOING EVERYTHING FOR US BUT WE HAVE MORE BANDWIDTH. IT FEELS LIKE

WE'RE RUSHING THIS. AND I APPRECIATE BEING EXCITED ABOUT IT, I ON ONE HAND DON'T WANT BUSINESS TO WAIT BUT ON THE OTHER HAND, I DON'T WANT TO BITE OFF MORE THAN WE CAN CHEW WHEN WE ARE SO BUSY AND SO SHORT-STAFFED RIGHT NOW. FEELS LIKE A PROJECT TO PLAN IN SPRING WHEN WE HAVE MORE STAFF TO HELP SPREAD THE LOAD. ALSO STAFF THAT WILL BE WITH US TO HELP IMPLEMENT THIS. EVEN THOUGH I APPRECIATE ALL YOUR TIME, OUR JOB IS TO MAKE POLICY NOT IMPLEMENTATION, WE NEED TO COUNT ON OUR STAFF TO TAKE IT AND RUN WITH IT. I HATE TO LAUNCH IT AND WE'VE DONE THESE TYPES OF THINGS BEFORE, WE'VE DONE STUDIES AND WE HAVE NO BANDWIDTH TO FILL THE POSITIONS. I WOULD RATHER WAIT ON THIS TILL SPRING, THAT'S MY FEEDBACK.

I DO UNDERSTAND THE CONCERNS ABOUT TIMING. BUT, COULD WE NOT JUST APPROVE THIS WITH, LIKE, A TIMING OF THE ACTUAL FORUM TVA? OR SHOULD WE JUST NOT CONSIDER THIS AT ALL? I'M TRYING TO GET A WILL OF WHERE MY COLLEAGUES ARE. COUNCILMEMBER CARTER?

OF COURSE, CONCILIATORY TO THE AMOUNT OF STAFFING TIME THAT WE HAVE, WE BASICALLY NEED TO INTERACT WITH THE CITY NOW. I THINK IT WOULD BE A SHAME TO ROLL IT OVER. THIS IS MOSTLY INFORMATION FOR THE CITY AND HOW IT CAN WORK. THEY CAN DO WHAT THEY NEED TO DO ON THEIR OWN AND BEGIN TO DO THAT, AND I HOPE THAT THEY WILL. BUT IN ORDER FOR THE CITY TO INTERACT NOW, IN THE FALL, IN CHRISTMAS, FOR ALL OF THESE THINGS THAT THE CITY DOES WITH THE DOWNTOWN, IS INFORMATION. I THINK ALL OF THAT IS USEFUL. THE AMOUNT OF TIME THAT, MAYBE A FOUR HOUR WORKSHOP TAKES, ISN'T SIGNIFICANT. BUT THE LEARNING THAT OCCURS WITH THAT, THE RELATIONSHIP THAT WE BUILD WITH OUR DOWNTOWN BUSINESSES, IS INVALUABLE. AND CAN HELP ALL THE WAY THROUGH CHRISTMAS SEASON, AND I THINK IT WOULD BE JUST A SHAME TO PUT IT OFF.

OKAY. FURTHER DISCUSSION?

YES. OUT OF RESPECT FOR THE GOALS SESSION THAT WE HAD ON APRIL 1st, THIS WAS A UNANIMOUS GOAL, I WOULD NOT FEEL COMFORTABLE PUSHING IT INTO NEXT YEAR. I THINK HAVING THIS SHOWS OUR DOWNTOWN BUSINESSES THAT WE'RE HERE FOR THEM, THAT WE CARE, THAT WE WANT TO KNOW MORE ABOUT WHAT THEY NEED. I LIKE THAT, I DO HAVE CONCERNS ABOUT OUR STAFF RIGHT NOW. DO WE HAVE THE BANDWIDTH TO IMPLEMENT, OR WHAT WE COULD DO IS GATHER THE INFORMATION, AND IMPLEMENTED IN TERMS OF OUR GOALS FOR NEXT YEAR. BECAUSE IT WOULD BE ONE WAY TO GATHER INFORMATION, AND MAKE GOALS FOR NEXT YEAR. SO MAYBE, BUT THEN AGAIN, YOU DO A STUDY AND THEN YOU DON'T, YOU DON'T IMPLEMENT IT, AND THE NEEDS CHANGE. SO, I, I WOULD ALSO HAVE CONCERNS WITH THE IDEA OF A FOUR HOUR WORKSHOP, I GUESS I THINK BUSINESS OWNERS ARE QUITE BUSY. I DON'T KNOW IF THEY HAVE THE BANDWIDTH FOR A FOUR HOUR WORKSHOP, I WOULD THINK MAYBE DO A COMBINATION OF THINGS, LIKE YOU HAVE A TWO HOUR WORKSHOP, GATHER PEOPLE, LET EVERYBODY TALK, TELL US WHAT YOU NEED. AND PARTNER THAT WITH A SURVEY , PARTNER WITH THE CHAMBER. AND THE DOWNTOWN, TO HELP IMPLEMENT THE PROJECT, HELP IMPLEMENT THE SURVEY. BUT DO IT MULTIFACETED BECAUSE MAYBE NOT EVERYONE COULD COME BUT THEY BE WILLING TO TAKE A SURVEY. BUT, SOMEHOW DO THOSE COMPLEMENTARY THINGS BUT DEFINITELY WORK WITH THE CHAMBER AND THE DOWNTOWN, ALTHOUGH THEY MIGHT BE MERGED RIGHT NOW, BUT, THAT WOULD BE MY SUGGESTION. AND I WOULD SUPPORT IT SOONER. RATHER THAN WAITING.

I SUPPORT NOT DELAYING THIS, EITHER. BACK TO YOU, COUNCILMEMBER CARTER, AFTER YOU'VE HEARD ALL OUR THOUGHTS, WHAT YOU THINK?

SO, JUST, TO HELP YOU WITH SOME OF THOSE ANSWERS, IT DOESN'T HAVE TO BE FOUR, IT CAN BE TWO, BUT, I'M ALMOST POSITIVE A SURVEY WON'T WORK. YOU CAN SURVEY YOUR LIFE OUT AND, UNLESS YOU HAVE DIALOGUE INTERACTION, DEBATE, AND FREE FLOW OF IDEAS, BRAINSTORMING, GETTING EVERYBODY TOGETHER IN ONE ROOM WHERE PEOPLE CAN INTERACT, IT'S NOT GOING TO ACCOMPLISH THE SAME THING THAT A SURVEY WOULD. AND WE DON'T HAVE TO, THIS ISN'T GOING TO BE A STUDY THAT WE BOOKSHELF, WE ARE GOING TO LEARN FROM IT IMMEDIATELY. AND IT'S GOING TO INFORM OUR DECISIONS AS A COUNCIL ON THE DAIS.

OKAY.

I'M NOT SUGGESTING THE SURVEY REPLACE THE WORKSHOP. I'M SAYING IT SUPPLEMENTS THE WORKSHOP. I THINK IT CAN BE HELPFUL TOOL. MY EXPERIENCE.

MORE DISCUSSION OR A MOTION? COUNCILMEMBER CARTER, DO YOU WANT TO MOVE? OF COURSE YOU CAN.

ALL RIGHT, I'M GOING TO MOVE THIS, CAN YOU HELP ME WITH THE WORDS?

YOU ARE GOING TO MAKE A MOTION TO APPROVE THE ECONOMIC GARDENING PROGRAMMING EVENT AND AUTHORIZE STAFF TO PROCEED WITH COORDINATION AND LIMITATION.

SO MOVED.

SECOND.

THANK YOU, SO MOVED BY COUNCILMEMBER CARTER, SECONDED BY MAYOR ZOLLMAN TO APPROVE THE ECONOMIC GARDENING PROGRAM EVENT AND AUTHORIZE STAFF TO PROCEED WITH COORDINATION AND LIMITATION, COUNCILMEMBER CARTER?

YES. COUNCILMEMBER HINTON?

YES.

COUNCILMEMBER MAURER?

YES.

MOTION PASSES 4-1 WITH COUNCILMEMBERS CARTER, HINTON, MAURER, MAYOR ZOLLMAN IN SUPPORT AND VICE MAYOR McLEWIS ABSENT.

MOVING ON TO A NUMBER 10, THE CONSIDERATION OF APPROVAL OF FEE WAIVER FOR THE LIVING PIECE WALL INDUCTION CEREMONY FOR SPECIAL EVENTS PERMIT FEES, WAIVERS SPECIAL EVENT PERMIT APPLICATION BE OF \$150 DAILY USE FEE OF 250, AMPLIFIED SOUND FEE OF \$50 FOR A TOTAL OF \$450. RESPONSIBLE DEPARTMENT IS THE CITY ENGINEER PUBLIC WORKS DIRECTOR, FISCAL IMPACT IS THE FEE WAIVER TOTAL OF \$450, AS I SAID AT THE BEGINNING, ABOUT RECUSING MYSELF ON THIS, I DID CHECK WITH ALEX, HE SAID YOU ARE ONLY REQUIRED TO RECUSE IF YOU RECEIVE COMPENSATION FOR THE ORGANIZATION WHICH IS NOT THE CASE, OR YOU WILL MAKE A DECISION BASED ON WHAT YOU BELIEVE IS IN THE BEST INTEREST OF THE ORGANIZATION, WHICH, I DO BELIEVE I WOULD, BUT, JUST TO BE IN AN ABUNDANCE OF CAUTION, EVEN THOUGH IT'S A NONPROFIT AND EVEN THOUGH I'M NOT ON THE BOARD BECAUSE I KNOW I CAN'T BE ON THE BOARD OF ANY OF THE ORGANIZATIONS, I'M JUST ON THE STEERING COMMITTEE, BUT IN AN ABUNDANCE OF CAUTION I'M GOING TO RECUSE MYSELF, LEAVE THE ROOM, TURNING IT OVER TO MARY, ALICE TO FACILITATE THE DISCUSSION.

COUNCILMEMBERS, NORMALLY IF THE MAYOR IS NOT THERE, VICE MAYOR WOULD PARTICIPATE, WOULD LEAD THE MEETING. ABSENT THAT OUR POLICY

TODAY IS THAT COUNCIL IS SUPPOSED TO DIRECT SOMEONE TO LEAD THE MEETING. TRADITIONALLY, THAT'S SOMEONE WHO'S HAD THAT ROLE BEFORE, AND IS THE MOST SENIOR, NORMALLY WE WOULD DESIGNATE. UNLESS THE COUNCIL FEEL STRONGLY IT MAKES SENSE JUST TO DESIGNATE COUNCILMEMBER HINTON FOR THIS BRIEF ITEM. IT LOOKS LIKE THERE'S CONSENSUS FOR THAT IF YOU'RE WILLING TO DO THAT.

SURE. AS THE MAYOR JUST ANNOUNCED THE ITEMS, IS THERE ANY QUESTIONS AT THIS POINT?

I'M LOOKING FOR A DATE ON THIS.

ALLOW ME TO TELL YOU THE DATE, RIGHT NOW IT'S SCHEDULED FOR SATURDAY, - FOR THE 13th, WHICH IS NOT THE FOLLOWING SATURDAY, HAVEN'T GOTTEN IT OFFICIAL YET, BUT THEY'RE HAVING SCHEDULING ISSUES.

THAT THE SAME DATE AS PORT CHEST, THE 13th.

OKAY. IT DOESN'T LOOK LIKE THERE'S ANYBODY REPRESENTING THE ORGANIZATION THAT WE COULD ASK QUESTIONS TOO. ARE THERE ANY OTHER QUESTIONS AT THIS TIME? MARY, HAVE WE GIVEN THEM A DISCOUNT IN THE PAST? SOMETHING THEY REQUESTED AND IS IN LINE WITH OUR PAST?

IT IS.

ALL RIGHT. SEEING NO OTHER QUESTIONS, CAN WE GO TO PUBLIC COMMENT?

THIS IS PUBLIC COMMENT ON THE REQUEST FOR THE WAIVER OF FEES FOR THE PIECE WALL, IF YOU'D LIKE TO MAKE A PUBLIC COMMENT I WILL COME TO IN CHAMBERS FIRST. SEEING THEM I WILL GO OUT TO ZOOM, IF YOU'D LIKE TO MAKE A PUBLIC COMMENT ON THE WAIVER OF FEES, PLEASE RAISE YOUR HAND VIRTUALLY. SEEING NONE, THERE IS NO PUBLIC COMMENT ON THIS ITEM.

OKAY. ANYBODY WANT TO, YEAH?

I WOULD LIKE TO MAKE THE MOTION TO SUPPORT THE FEE WAIVER.

SECOND.

OKAY, WE HAVE A FIRST AND SECOND, MARY?

SO MOVED BY COUNCILMEMBER CARTER, SECONDED BY COUNCILMEMBER MAURER TO APPROVE THE FEE WAIVER FOR THE PEACEFUL INDUCTION CEREMONY. IN THE AMOUNT OF \$450. COUNCILMEMBER CARTER?

YES.

COUNCILMEMBER MAURER?

YES.

COUNCILMEMBER HINTON?

YES.

VICE MAYOR McLEWIS?? AND MAYOR ZOLLMAN ARE ABSENT, MOTION PASSES 3-2 WITH COUNCILMEMBERS CARTER, MAURER, HINTON IN SUPPORT, VICE MAYOR McLEWIS AND MAYOR ZOLLMAN ABSENT, I WILL GO GET THE MAYOR TO RETURN TO THE DAIS. THERE HE IS.

MAKE SURE. OKAY. SO, AGENDA ITEM 11. WE'RE NOT DOING. SO NOW ADDITIONAL PUBLIC COMMENT FOR ITEMS NOT ON THE AGENDA.

SO THIS IS THE TIME FOR MEMBERS OF THE PUBLIC WHO ARE NOT ABLE TO SPEAK DURING THE FIRST PUBLIC COMMENT PERIOD TO SPEAK DURING THIS PUBLIC COMMENT PERIOD IF YOU'D LIKE TO MAKE A PUBLIC COMMENT I WILL GO TO CHAMBERS FIRST. SEEING THEM I WILL GO OUT TO ZOOM, IF YOU'D LIKE TO MAKE A PUBLIC COMMENT DURING THE SECOND PUBLIC COMMENT PERIOD AND YOU DID NOT SPEAK AT THE EARLIER ONE, PLEASE RAISE YOUR HAND VIRTUALLY. SEEING NONE, THERE IS NO PUBLIC COMMENT.

THANK YOU, NOW WE'RE MOVING INTO THE LAST PART, WHICH IS COUNCILMEMBER REQUEST FOR FUTURE CITY COUNCIL AGENDA ITEMS, ARE THERE ANY OTHER ITEMS FROM MY COLLEAGUES? LOOKING TO MY RIGHT, LOOKING TO MY LEFT, SEEING NONE. WE'RE GETTING INTO CITY COUNCIL STAFF REPORT OUTS AND TO OUR WONDERFUL INTERIM CITY MANAGER FIRST.

THANK YOU, MAYOR. I WON'T READ THEM ALL, BUT ATTACHED TO THE PACKET IS THE DEPARTMENTAL REPORTS FOR THE MONTH OF JUNE OF THE SIGNIFICANT ACTIVITIES THAT ARE HAPPENED, WE DID RECEIVE, YOU WILL SEE IT IN YOUR HIGHLIGHTS THIS WEEK, WE DID RECEIVE A CHECK FROM GRAFTON COMMONS FOR THEIR BILLING PERMIT, YESTERDAY. AS I SAID AT THE LAST MEETING THE REQUEST FOR PROPOSALS FOR THE CITY MANAGER RECRUITING FIRM WILL BE COMING AT THE NECK CITY COUNCIL MEETING FOR APPROVAL AT THE COUNCIL CONSIDERATION OF APPROVAL AND THAT IS ALL I HAVE.

GREAT, TO MY COLLEAGUES FOR THEIR REPORT OUTS? COUNCILMEMBER HINTON? SURE. I ATTENDED THE EXECUTIVE COMMITTEE FOR SCT CA, AND THE FULL BOARD MEETING, ON JULY 14th, THE MAIN ITEMS THAT ARE HAPPENING IS THAT A CLOVERDALE HAS PULLED OUT OF THE BAY WRITTEN PROGRAM BY A VOTE OF THEIR COUNCIL AND SEVASTOPOL IS THE LAST CITY MUNICIPALITY STANDING IN BAY RAN WHICH IS OUR WATER SAVING MEASURE THAT WE APPROVED IN OUR CPA HAS MANAGED FOR AS MANY YEARS AS IT'S BEEN IN EXISTENCE. THEY HAVE A PROPOSAL THAT THEY'RE GOING TO GO BACK AND TRY TO, THEY THINK THAT'S GOING TO BE DISSOLVED. AS I'VE REPORTED BEFORE, THEY HAVE AT LEAST ONE FULL-TIME AND ONE PART-TIME PERSON THAT WORKS IN THEIR ORGANIZATION THAT WILL BE IMPACTED IF THAT FUNDING IS LOST. THEY'RE GOING TO WIND IT DOWN AND ARE NOT ACTIVELY SOLICITING IN THE CITY OF SEVASTOPOL BECAUSE THEY GOT TO WIND US DOWN FROM THIS OFFICIAL PROGRAM. IF IT IS DISSOLVED, AND IT'S LOOKING LIKE THAT IS WHERE IT'S GOING. THEY ARE HOPEFUL THAT ANOTHER CLIMATE ACTION TYPE OF PROGRAM IS APPROVED, AND I DON'T HAVE A LOT OF DETAILS ON THAT. AND IT WOULD BE BAY AREA WIDE AGAIN, AND IF IT'S APPROVED THEN, THEY WILL BE ABLE TO REALLOCATE THE POSITIONS WITHIN THE ORGANIZATION. WITH NEW FUNDING. SO, THAT'S A PRETTY BIG THING FOR OUR CPA, JUST, EVERYBODY IS HOPEFUL THAT THAT WILL GET RESOLVED, THESE ORGANIZATIONS USE A LOT OF TERMS LIKE MASCOTS, SO I GRABBED A COUPLE OFF THE TABLE. BECAUSE THE OTHER THING IS THAT REALLY HAPPENING, BUT THERE'S A LOT OF TALK AND IT WAS BROUGHT UP TONIGHT, BUT, THAT MOST WRITERS ARE CHOOSING RIGHT FOR THEIR REGIONAL TRIP, SO THERE IS MASCOTS DOING A STUDY AND RECOMMENDING THAT GOLDEN GATE TRANSIT BUS TRIPS ARE REDUCED. THAT ONLY SOME ARE OFFERED THAT ARE LONGER COMMUTE, THAT WOULD GO ALL THE WAY INTO THE BAY AREA WITHOUT THE STOPS ALONG THE WAY. IT DOES DESERVE SINCE WE HEARD FROM A SPEAKER THAT I HAVE CONTINUED TO BE VERY, VERY VOCAL SINCE I WAS ELECTED IN 2016 ABOUT US PAYING AND NOT GETTING REPRESENTATION ON THAT BOARD. MANY, MANY PEOPLE KNOW ABOUT THIS, I'VE TALKED TO GRACE ROGERS AND MARK McGWIRE AND VICTORIA FLEMING, THEY HAVE PROMISED THAT OUR VOICES WILL BE HEARD. SEVASTOPOL AND CITY OF SONOMA ARE IN THE SAME BOAT. WE DO KNOW THAT THEY ARE GOING OUT FOR A TAX EXTENSION. I HAVE NOT YET ENDORSED THAT CAMPAIGN ALTHOUGH I HAVE BEEN ASKED TO, BECAUSE I WOULD REALLY LIKE TO GET OUR PROBLEM SOLVED, SO I JUST WANT TO PUT THAT OUT THERE, WE DO WORK ON THESE REGIONAL BOARDS AND WE WORK WITH OUR ELECTED FOLKS AND A LOT OF TIMES THOSE ELECTED FOLKS THAT WE GET TO KNOW AT THE

LOCAL LEVEL GO ON TO REPRESENT US IN SACRAMENTO AND THAT GIVES US A LITTLE MORE. AND ALSO IT'S A SIDE NOTE BUT WE DID SEE ON OUR CONSENT CALENDAR THAT WE WORKED REALLY CLOSELY WITH THE COUNTY OF SONOMA TO GET OUR SALES TAX IMPLEMENTED IN A POSITIVE WAY. SO SOMETIMES THESE THINGS AREN'T OBVIOUS TO THE PUBLIC BUT I THINK THAT WE'RE DOING A REALLY GOOD JOB ON THAT. ANYWAY, THAT'S MY VERBAL REPORT OUT. IT WAS THE SHORTEST MEETING I'VE EVER READ ATTENDED. AT OUR CPA. THIS FRIDAY OR THIS MONDAY. THIS LAST MONDAY, THANKS.

THANK YOU, COUNCILMEMBER MAURER?

I STARTED A PROJECT, I WANTED TO LET COUNCIL AND STAFF KNOW, OF OUR COMMUNITY DEVELOPMENT DIRECTOR WAS TALKING ABOUT A GRANT SHE WANTED, A CULTURAL GRANT, AND SO I STARTED GATHERING INFORMATION ABOUT SEVASTOPOL AND WHAT'S UNIQUE ABOUT SEVASTOPOL, WHAT IS SEVASTOPOL'S HISTORY AND CULTURE, AND HOW MANY RESTAURANTS DO WE HAVE IN TOWN? SO I CREATED A SPREADSHEET OF ALL THE RESTAURANTS, I THINK I'M UP TO 97 PLACES THAT YOU CAN GET TO EAT OR DRINK. AND I INCLUDED HOT BARS, AND FIESTA AND ALL THESE PLACES BUT, I WANTED TO OFFER IF ANYBODY WANTED A COPY OF THAT, I CAN SEND IT TO MARY AND OFFER TO COUNCIL. YEAH. SO, MY GOAL IS TO TRY EVERY SINGLE PLACE. AND I'M HAVING FUN WITH THAT. I'M A LIAISON TO THE CENTER FOR THE ARTS, I WENT TO THEIR BELONGING PROJECT, THEY HAVE ALL THIS REALLY COOL PUBLIC ART AND THEY HAD IT OPEN SO YOU COULD WALK THROUGH THE FENCE, AND THAT WAS REALLY NICE, I'VE BEEN TO PEACE TOWN, MY HUSBAND AND I CELEBRATED OUR 25th WEDDING ANNIVERSARY. SO THAT WAS A BIG DEAL FOR ME, MEANINGFUL TO ME, THAT'S ALL.

COUNCILMEMBER CARTER?

CAN I JUST ADD ON THAT I DIDN'T GET A REPORT OUT BY RESTAURANT WALK, YOU JUST REMINDED ME, I DID WANT TO SAY THAT I DID MY FIFTH ANNUAL, I WALKED LOCAL AND SEVASTOPOL ON THE 28th OF JUNE, AND WE DIDN'T HAVE TIME TO REPORT IT OUT, BUT THAT IS A SUPER POPULAR WALK, DID SOME NEWER RESTAURANTS, WE HAD SOME OLD FAVORITES, YOU JUST LOST ONE FROM ROMAN THAT'S MOVING TO TEXAS AND HE'S DONE MY WALK, I THINK, EVERY YEAR. IT WAS A SPECIAL TIME. AND I AGREE, WE HAVE SO MANY GREAT RESTAURANTS, AND WE GOT TO STUFF OURSELVES THAT MORNING.

IN ADDITION TO MY REGULAR MEETINGS, THE VICE MAYOR AND I HAVE SPENT A SUBSTANTIAL AMOUNT OF TIME, AGAIN, GETTING BACK TO THE PUBLIC COMMENT ABOUT WHAT THE COUNTY IS DOING, SPECIFICALLY IN REFERENCE TO ELDERBERRY COMMONS, AND WITH THE PENDING STARTING THE DIGGING, FOR OUR COMMONS. LOTS OF MEETINGS. HUGE MEETINGS. ALEX, MARY, ATTENDED ONE, WHICH WAS A STATUS CHECK IN, WITH SUPERVISOR HOPKINS AND A TON OF PEOPLE FROM THE COUNTY, TO TALK ABOUT WHAT IS THE PLAN FOR REDUCING THE CITY EXPENSES BY WAY OF POLICE TIME AND THE RESPONSE TO ELDERBERRY COMMONS. A LOT OF DIFFERENT THOUGHTS ABOUT WHETHER THE CITY COUNCIL, AT ANY TIME, LOADED TO APPROVE THAT PROJECT. STATEMENTS WERE MADE, TO THE FACT THERE WAS A VOTE. ONE VERSION OF THIS COUNCIL TO APPROVE THAT PROJECT. SINCE THAT STATEMENT WAS MADE, THERE'S BEEN RESEARCH CONDUCTED AND MOVING FORWARD WITH WHAT WE'RE GOING TO DO TO THE COUNTY ABOUT WHETHER ANY CITY COUNCIL DID EFFECTIVELY VOTE TO HAVE THAT PROJECT HAPPEN. AND ONCE THAT DECISION HAS BEEN REACHED, ABOUT HOW TO PROCEED WITH THAT, ALSO, FOR THE MEMBERS OF THE PUBLIC THERE

WILL BE AN FAQ ABOUT THIS PROJECT AND IT WILL BE LAUNCHED ON THE CITY SITE. SPECIFICALLY ABOUT OUR REQUEST, REIMBURSEMENT FROM POLICE, THAT WAS A NO. THAT CAME OUT OF THAT MEETING ALONG WITH A FEW OTHER THINGS. I WILL SAY TO THE MEMBERS OF THE PUBLIC ESPECIALLY QUESTIONING WHAT ARE WE DOING, ON OUR DIFFERENT TRANSITIONAL HOUSING, A LOT OF WORK HAS BEEN ALLOCATED AND A LOT OF WORK CONTINUE TO BE ALLOCATED IN REFERENCE TO WHAT'S GOING ON AT GROVE AND STEEN COMMONS. THE PENDING WORK, AND THE ONGOING WORK AT ELDERBERRY COMMONS. TO THE POINT WHERE IT IS NOT JUST US, MAYORS, FIVE OF US STARTED TO MEET WITH THE DIRECTOR OF THE HOMELESS DIVISION, OUR NEW DIRECTOR OF THE HOMELESS DIVISION, WHO I MENTIONED, HOPEFULLY EVERYONE WILL HAVE ON THEIR CALENDAR TO COME AND ASK HIM MANY QUESTIONS ON AUGUST 5th BECAUSE HE, ALONG WITH A FEW OTHER PEOPLE FROM THAT DEPARTMENT WILL BE COMING TO ANSWER ALL OF OUR QUESTIONS ABOUT HOW MUCH DO WE PAY FOR EACH OF THE HOMELESS PEOPLE? QUESTIONS LIKE THAT, AND ALSO, REIMAGINING HOW, WITH A LIMITED AMOUNT OF RESOURCES WE HAVE, AND THE PENDING SLASHING OF THOSE MONEY, WHAT ARE WE REALLY GOING TO DO? IN REFERENCE TO THOSE THAT ARE VULNERABLE ON OUR STREETS, POLICE, OTHER NEEDED RESPONSES. I SAY ALL THAT, THE FACT THERE'S A LOT OF WORK, MAYBE WE'RE NOT DOING A GOOD JOB OF COMMUNICATING IT BUT WE'LL TRY TO DO BETTER ON THAT FRONT. THOSE ARE MY COMMENTS.

I WAS JUST WONDERING IF WE COULD GET A CALENDAR INVITE FOR THAT, AUGUST 5th THING. I WILL FORGET.

THAT WILL BE COMING HERE.

THAT WILL BE AT THE CITY COUNCIL MEETING, THE PRESENTATION.

AND FOR EVERYONE TO KNOW, PLEASE MARK IT ON YOUR CALENDAR.

I'M SORRY, OUR PUBLIC WORKS, CITY ENGINEER HAS LEFT, I KNOW THE COUNCIL KNOWS THIS AND STAFF KNOWS THAT BUT FOR MEMBERS OF THE PUBLIC MARK HAS ANNOUNCED HIS RETIREMENT. SO HIS LAST, HIS RETIREMENT DATE IS AUGUST 10th, HIS LAST DAY IS JULY 24th. SO, I WILL BE HAVING AN INTERIM CITY ENGINEER FOR NOW SO THAT WE CAN SIGN ALL OF OUR GRANTS, CALTRANS PERMITS, THINGS LIKE THAT, AND BE DOING A RECRUITMENT FOR THAT POSITION AS WELL. AND BASED, COUNCILMEMBER MAURER ON THE PUBLIC, THE CALLS, I WANT TO SAY THERE'S A SPECIAL MEETING NEXT WEEK, THE PUBLIC ARTS COMMITTEE WILL BE HAVING A SPECIAL MEETING TO TALK ABOUT THE CULTURAL OUR DISTRICT GRANT, IF ANYONE IS INTERESTED IN THAT, THAT ITEM WILL BE COMING TO THE COUNCIL AUGUST 5th TO SUBMIT THE APPLICATION, AND REGARDING THE RIGHT AID, I WILL TELL YOU THAT I HAVE INITIATED A LETTER TO RITE AID TO ASK WHAT THE STATUS IS OF THAT BUILDING, IF THEY'RE GOING TO TELL ME OR NOT IS ANOTHER QUESTION. I DID PUT IN SOME INQUIRIES AND I WILL LET YOU KNOW.

ONE OTHER THING I JUST REMEMBERED, BECAUSE ON OUR COUNCIL MEETING FOR SEPTEMBER 5th, FOR THOSE THAT HAVE A LOT OF QUESTIONS ABOUT GRAB AND STEEN COMMONS, WE'VE INVITED JACK TIBBETTS TO DO AN INFORMATIONAL PRESENTATION TO US, ABOUT THE STATUS OF THIS ONGOING FUNDING FOR THIS PROJECT, BECAUSE THERE IS, AGAIN, CONCERNS ABOUT WHETHER THE FUNDING IS GOING TO MANIFEST ITSELF FOR THE TIMING WHEN ALL THIS NEEDS TO HAPPEN. WE'RE DOING OUR BEST TO GET THE COMMUNITY THE INFORMATION ABOUT THESE PROJECTS, SO, SORRY, I THINK I CUT YOU OFF.

I WANTED TO FOLLOW UP WITH THE RIGHT AID, I DON'T KNOW WHAT I'M ALLOWED TO ASK BUT, HOW CAN, CAN WE PUT RESTRICTIONS ON WHAT THAT BUILDING CAN BE, OR CAN WE THINK ABOUT --

WE HAVE A ZONING CODE THAT PUTS RESTRICTIONS ON WHAT THAT BUILDING WOULD BE. SO, IF THE COUNCIL WOULD HAVE TO AMEND THE ZONING CODE IF THEY WANT TO UPDATE. WHAT IS ALLOWED, THERE.

SINCE WE HAVE SOME CODE ABOUT, WHAT IS IT, FRANCHISE BUSINESSES? DOES THAT AFFECT WHAT CAN GO IN THERE?

POTENTIALLY, YES.

OKAY.

IT REALLY DEPENDS ON WHAT THE PROPOSED REUSE IS. WE DON'T KNOW. THERE IS AN ORDINANCE.

THAT BUILDING IS NOT COVERED BY THE FORMULA BUSINESS ORDINANCE.

IT IS WITHIN DOWNTOWN. THE ZONE.

IT IS.

GREAT. ANY OTHER COMMENTS BEFORE WE ADJOURN?

JUST A COMMENT TO THANK OUR INTERIM CITY MANAGER, MARY CURLEY, WHO IS DOING A FABULOUS JOB, AND SHE WAS STELLAR CITY CLERK, ASSISTANT CITY MANAGER AND YOU'RE BRINGING THAT SAME QUALITY TO THE CITY MANAGER POSITION, AND I WANTED TO SAY THAT PUBLICLY. SO GRATEFUL, THANK YOU SO MUCH FOR ALL YOU DO FOR US.
