Subject: Weed Abatement Public Hearing

RECOMMENDATIONS:

That the City Council conduct the public hearing regarding weed abatement and adopt the attached resolution.

EXECUTIVE SUMMARY:

The City's weed abatement program exists to address safety issues pertaining to overgrown. Owners of vacant parcels are notified of their responsibility to remove overgrown weeds in a timely manner. This program plays a crucial role in maintaining the City's health and safety by mitigating the spread of potential fires and by enhancing the community's aesthetic appeal.

BACKGROUND AND DISCUSSION:

At the May 20, 2025 City Council Meeting, the Council adopted a Resolution declaring weeds a public nuisance and set a date for Public Hearing of June 17, 2025 in order to provide property owners a means of protesting the removal of weeds on their property.

If after hearing any and all objections from property owners identified for abatement, the City may conduct onsite assessment and remove any parcels it deems appropriate from the weed abatement program.

After those properties are removed, if any, then the attached Resolution may be acted upon. This Resolution empowers City Staff to enter upon identified properties and abate weeds/fire hazards and invoice the property owners for the cost of abatement plus administrative costs.

STAFF ANALYSIS:

With the ongoing threat of vegetation fires and pursuant to Sebastopol Municipal Code Chapter 8.56, staff recommend the continuation of the City's Weed Abatement Program.

COMMUNITY OUTREACH:

This item has been noticed in accordance with the Ralph M. Brown Act and was available for public viewing and review at least 72 hours prior to schedule meeting date. The property owners have been notified.

FISCAL IMPACT:

There is no fiscal impact with this item tonight, however, if the property owner fails to abate their lots, a contractor hired by the Fire Department will abate the lots and the property owner will be billed for the cost of abatement plus administrative costs.

WHEREAS, the Fire Chief has reported that certain owners of properties have not abated and removed weeds and other fire hazards from their property, and		
WHEREAS, Sebastopol Municipal Code Chapter 8.56provides for an abatement procedure and hearing,		
WHEREAS, the City Council conducted a duly noticed public hearing on June 17, 2025, at which time they heard comments and protests from all interested property owners.		
NOW THEREFORE, BE IT RESOLVED that the weeds on properties listed on the attached Exhibit "A" are hereby declared to be a Public Nuisance.		
BE IT FURTHER RESOLVED that if a property owner fails to abate or destroy such nuisance weeds, the Fire Chief is hereby ordered to abate or cause to be abated such nuisance weeds pursuant to Sebastopol Municipal Code Chapter 8.56, and that the expense thereof shall be assessed upon the lot or lands from which such weeds shall have been destroyed or removed.
