# RECOMMENDATION()S:

That the Council receive the report on Police Department Responses to Calls at the newly Opened Elderberry Commons Facility located at 6751 Sebastopol Avenue.

# **EXECUTIVE SUMMARY:**

Elderberry Commons, located at 6751 Sebastopol Avenue in Sebastopol, California, is a permanent supportive housing community developed to assist individuals experiencing homelessness. The site was formerly the Sebastopol Inn and was acquired by the County of Sonoma (through the Sonoma County Community Development Commission) in December 2020 using funds from California's Project Homekey program, which aims to convert commercial properties into housing for vulnerable populations. It is our understanding from the Development Agreement the project was funded as follows:

- Two Million Six Hundred Thousand Dollars (\$2,600,000) from Commission Whole Person Care funds.
- Six Hundred Thousand Dollars (\$600,000.00) in Providence Health grant funding.
- The project also received funding from the U.S. Department of Housing and Urban Development (HUD) HOME Program and the project received \$203,871 in HOME funds and an additional \$128,775 as a Community Housing Development Organization (CHDO) set-aside.

The property was transferred from the Sonoma County Community Development Commission to Burbank Housing Development Corporation (Burbank) to own and operate the permanent supportive housing development. Burbank has contracted with West County Community Services (WCCS) to provide services to residents of the development. The former hotel rooms were converted into units compatible with permanent supportive housing (which include kitchenettes) and the property is managed by Burbank.

# BACKGROUND

As of mid-March 2025, Elderberry Commons reached full occupancy, with all units leased to individuals qualifying for supportive housing . As of the writing of this report, a total of 39 persons living at Elderberry Commons.

Leasing operations are managed by Burbank Housing (Burbank). West County Community Services (WCCS) provides on-site support services at Elderberry Commons through a direct services agreement with Burbank.

WCCS is contracted by Burbank to deliver supportive services to residents of Elderberry Commons. The objective is to engage residents, build relationships, and connect them to appropriate community services and referrals based on individual needs. The staffing model, aligned with HUD's case manager-to-resident ratio, includes:

- Two (2) full-time case managers
- One (1) full-time services navigator
- One (1) part-time housing specialist
- Tenant Intake and Lease-Up Process

All potential tenants are referred exclusively through the Coordinated Entry system. In accordance with this system, no eligible applicant may be denied access to available housing at Elderberry Commons.

WCCS case managers provide services strictly during the lease-up phase:

- Receive referrals via Coordinated Entry
- Make initial contact with potential tenants
- Assist with the collection of required documentation
- Review and execute lease agreements with tenants
- Submit completed lease documents to Burbank

Following lease execution, Burbank assumes full responsibility for property management and ongoing tenancy matters.

# Outreach Services within the City of Sebastopol

Separately from its work at Elderberry Commons, WCCS also holds a contract with the City of Sebastopol to provide outreach services to unhoused individuals residing within city limits. This agreement includes:

- One (1) part-time Outreach Coordinator, working 20 hours per week
- Position funded at \$40,000 annually through the Sebastopol Police Department budget

The Outreach Coordinator's core responsibilities include:

- Establishing ongoing contact with unhoused individuals in Sebastopol
- Building trust through consistent engagement
- Connecting individuals to services and resources with the goal of transitioning them into supportive housing

It is important to note that the services WCCS provides under contract with Burbank at Elderberry Commons are distinct and separate from the outreach services provided through the City of Sebastopol.

### **DISCUSSION:**

Elderberry Commons is a residential property managed by Burbank Housing, located within the City of Sebastopol. Since the facility opened earlier this year, the City has received multiple community complaints specifically related to incidents and activity at this address. In response to these concerns, the Mayor and Vice Mayor have requested a report summarizing law enforcement responses at Elderberry Commons.

This agenda item provides the City Council and the public with a transparent summary of calls for service responded to by the Sebastopol Police Department at Elderberry Commons.

- 123 routine and proactive security patrols of the location
- 13 calls relating to disturbing the peace
- 8 calls for welfare checks & unwanted subjects
- 7 arrests
- 9 other calls for service
- 1 call relating to a suicidal party

It should be noted that in the event of an arrest, there is no guarantee that the Sonoma County District Attorney's Office will file charges or pursue prosecution. Charging decisions are made solely at the discretion of the District Attorney and are based on multiple factors, including the facts of the case, the strength of the available evidence, and prosecutorial priorities. As a result, an individual who is arrested may ultimately be released without any charges being filed.

In most cases, individuals arrested for non-felony offenses are not held in jail. If someone is taken into custody, the law requires that they be arraigned—formally charged in court—within 48 hours. However, if the Sheriff's Office or our agency issues a citation and release, the arraignment may be scheduled for a later date.

We have reviewed the Sheriff's Office policies and found no specific provisions regarding custody decisions in these situations. Each case is evaluated individually, with many contributing factors influencing the final decision on detention or release. While staff was asked to gather statistics on arrests and subsequent detentions, data from the court regarding how many individuals remained in custody following arrest was not available at the time of this report.

Additionally, it is important to understand that individuals cannot be placed on a 5150 psychiatric hold solely due to being under the influence of drugs or alcohol.

### STAFF ANALYSIS:

As of the writing of this report, the Sebastopol Police Department has recorded a total of 48 hours and 23 minutes of on-scene time in response to calls for service at Elderberry Commons during the reporting period.

It is important to note that this figure does not include time spent by officers on related activities such as:

- Report writing and documentation
- Administrative follow-up
- Arrest or transport procedures
- Booking processes
- Interagency coordination or investigative follow-up

Unless explicitly noted in the attached CAD documentation, these additional duties are not reflected in the 48 hours and 23 minutes. Therefore, the actual time commitment associated with Elderberry Commons-related incidents is significantly higher than the on-scene time alone. While all police responses to Elderberry Commons have been conducted within the existing Sebastopol Police Department budget, staff has provided an estimated cost of personnel time associated with these calls for service for the purpose of transparency and understanding of resource allocation. This estimate is outlined in the Fiscal Impact section below.

This report is informational and intended to support:

- Community awareness
- City Council discussion
- Future dialogue with Burbank Housing regarding property management and addressing police responses

Policy D-6: Sebastopol will work to prevent homelessness and support housing services for the homeless. Action D-11: Encourage the Urban County to provide financial support for area homeless facilities and services that serve Sebastopol area residents through ESG and other available funding sources. Encourage the Sonoma County Community Development Commission/Urban County to monitor the needs of the homeless population in Sebastopol.

# FISCAL IMPACT:

As noted above, staff has provided an estimated cost of personnel time associated with these calls for service for the purpose of transparency and understanding of resource allocation. Average Costs of Police Officer Response (\$86.44 hourly with benefits): 48 Hours x 86.44 = \$4149.12.

# COMMUNITY OUTREACH:

This item has been noticed in accordance with the Ralph M. Brown Act and was available for public viewing and review at least 72 hours prior to schedule meeting date. The City has also used social media to promote and advertise the City Council Meeting Agenda Items.

As of the writing of this agenda item report, the City has received numerous complaints related to Elderberry Commons which have been included in the statistics above. Staff anticipates additional public comments upon the posting of this agenda report. If staff receives public comment from interested parties following the publication and distribution of this agenda item report, such comments will be provided to the City Council as supplemental materials before or at the meeting and will be posted to the city website.

# **RESTATED RECOMMENDATION(S):**

That the Council receive the report on Police Department Responses to Calls at the newly Opened Elderberry Commons Facility located at 6751 Sebastopol Avenue and provide any feedback to the Chief of Police regarding any concerns or recommendations moving forward. City staff will be working to arrange a meeting with Burbank Housing.
