admin to start soliciting ideas for the celebration as well as ways to fund it.

Recommendation: That the City Council Provide direction to staff

RECOMMENDATION:

That the City Council consider establishing an Ad Hoc Committee to begin planning for the City's 125th Anniversary Celebration, appoint two Councilmembers to serve on the committee, and authorize allocation of limited staff time to support initial coordination efforts.

EXECUTIVE SUMMARY:

The City of Sebastopol will celebrate its 125th Anniversary of incorporation in 2027. This milestone represents an opportunity to honor Sebastopol's history, celebrate its diverse community, and promote local culture, arts, and increase economic vitality.

BACKGROUND

The City of Sebastopol was incorporated in 1902 and will celebrate its 125th Anniversary in 2027. As with previous milestone events, early preparation is essential to ensure a meaningful, inclusive, and well-organized celebration that reflects the values and diversity of the Sebastopol community.

DISCUSSION:

If approved, the Ad Hoc Committee could serve to:

- Coordinate with businesses, nonprofit organizations, and public agencies to generate ideas for events and commemorative activities;
- Identify potential funding sources including sponsorships, donations, and grants; and
- Develop a proposed scope of work and estimated funding plan to bring back to the City Council for review, discussion, and direction at a future meeting.



• The intent is to begin early community engagement and concept development while maintaining Council oversight over all final decisions related to the event as all recommendations from the committee will be submitted to the Council for consideration at a publicly noticed City Council meeting.

FISCAL IMPACT:

Proposed scope of work and any future budget requests for the 125th Celebration will be developed by the Ad Hoc Committee and presented to the City Council for review and approval at a later date.

RESTATED RECOMMENDATION:

That the City Council:

- Approve the creation of an Ad Hoc Committee for the 125th Celebration of the Incorporation of the City of Sebastopol (1902–2027);
- Appoint two Councilmembers to serve on the Ad Hoc Committee;
- Authorize limited staff time to support coordination and outreach with community partners, local businesses, nonprofits, and public agencies to solicit ideas and explore funding opportunities; and
- Direct the Ad Hoc Committee to develop a proposed scope of work and estimated funding plan and return to the City Council for discussion and direction.
