RECOMMENDATION:

That the City Council adopts the attached Resolution Setting the Public Hearing in order to proceed with the City's Weed Abatement Program.

EXECUTIVE SUMMARY:

This item is to request the City Council to approve the attached Resolution declaring weeds growing upon private properties within the City a fire hazard and a public nuisance and set a public hearing date on June 17, 2025 for those who object to the proposed removal of weeds from their lots.

BACKGROUND AND DISCUSSION:

Every year a number of private properties are declared to be a fire hazard, therefore a public nuisance and in need of abatement. The resolution is passed and adopted, and a date set for a public hearing for those owners who object to this resolution. The hearing date will provide us sufficient time to legally notice all of the affected property owners of the public hearing. This is an annual program for weed abatement in the City. Sebastopol Municipal Code Chapter 8.56 provides for an abatement procedure and hearings.

The attached Resolution signifies the beginning of the City's Annual Weed Abatement Program. The Resolution declares weeds a public nuisance and sets a date for a public hearing to provide property owners with a means of protesting the removal of weeds on their property.

The parcels of land listed on Exhibit "A" (attached) historically have weeds thereon. This list is adjusted as parcels are developed or we are notified of repeat locations. These weeds have the potential to become a fire hazard in the very near future as summer weather patterns cause the weeds to become dry and combustible. If the weeds on these parcels are not removed by July 30^{th,} 2025, the City will abate the fire hazards and bill the property owners for the cost of abatement plus administrative costs.

STAFF ANALYSIS:

In recognition of National Wildfire Awareness Month, the ongoing threat of vegetation fires, and pursuant to City Sebastopol Municipal Code Chapter 8.56, staff recommends continuing the City's Weed Abatement Program.

PUBLIC COMMENT:

As of the writing of this staff report, staff has not received any public comments. If staff receives public comment from interested parties following the publication and distribution of this staff report such comments will be provided to the City Council as supplemental materials before or at the meeting.

COMMUNITY OUTREACH:

This item has been noticed in accordance with the Ralph M. Brown Act and was available for public viewing and review at least 72 hours prior to the scheduled meeting date. The City has also used social media to promote and advertise the City Council Meeting Agenda Items.

FISCAL IMPACT:

There is no fiscal impact with this item tonight; however, if the property owner fails to abate their lots, a contractor hired by the Fire Department will abate the lots and the property owner will be billed for the cost of abatement plus administrative costs.
