Subject: Request for Approval to Utilize Measure H funding to cover one fire engine payment

> totaling \$231,335.50, as agreed upon through reorganization negotiations and approve Resolution authorizing budget amendment to allocate Measure H funds for fulling the

financial obligation schedule in the reorganization agreement

#### **RECOMMENDATIONS:**

Request for approval to utilize Measure H funds and amend the budget to cover the expenditure for a new Type 1 fire engine, as agreed upon through the reorganization process and approve resolution for budget amendment. This allocation is essential to fulfill the financial commitments outlined in the reorganization agreement.

#### **EXECUTIVE SUMMARY:**

The City of Sebastopol is projected to receive approximately \$840,000 in Measure H sales tax revenue this fiscal year. As part of the reorganization negotiations with the Gold Ridge Fire Protection District (GFD), a plan was developed to complete the debt financing of a new fire engine to limit future obligations, thereby streamlining reorganization efforts. Currently, the City owes two installment payments of \$238,050.49 each.

Community Leasing Partners provided a payoff quote to reduce the loan's interest rate. Both entities' Fire Ad Hocs agreed to share the cost of these payments. Paying off the obligation in full at this time will avoid interest costs associated with the financing, resulting in an estimated savings of \$13,429.98. The City will contribute one payment using Measure H funds, while GFD will fund the other. The City's total contribution toward the final payoff is \$231,335.50.

### **BACKGROUND AND DISCUSSION:**

On August 3, 2023, the City of Sebastopol entered into a financing agreement with Community Leasing Partners to purchase a new Pierce Enforcer Type-1 fire engine, with a total acquisition cost of \$938,744.82. A \$300,000 down payment was made on August 17, 2023, leaving a financed balance of \$638,744.82. The balance is to be repaid in three annual installments at an interest rate of 5.79%, resulting in total interest of \$75,406.65. Below is the original amortization schedule of payments for the engine:

In Fiscal Year 24-25, the City made the first installment of \$238,050.49, leaving two remaining payments for FY25-26 and FY26-27. Initially, the second payment was planned for the FY25-26 budget; however as part of the fire department's reorganization negotiations with the Gold Ridge Fire Protection District (GFD), both agencies, through their respective Ad Hoc committees, agreed to share the remaining obligation and advanced the two remaining payment to this fiscal year 24-25, with the City funding one payment and GFD funding the other. The City's portion will be paid using Measure H sales tax revenue.

Measure H, formally known as the Improved and Enhanced Local Fire Protection, Paramedic Services, and Disaster Response Initiative, was approved by Sonoma County voters in Spring 2024. The measure established a countywide ½-cent sales tax expected to generate approximately \$60 million annually for local fire agencies. Distributions are made quarterly on the tenth of February, June, September, and December. The City of Sebastopol is projected to receive approximately \$1.1 million annually and received \$282,451.47 on March 10, 2025, with the next installment expected on June 10, 2025.

### STAFF ANALYSIS:

Staff recommends approving the utilization of Measure H funds to cover the City of Sebastopol's shared and advanced this one final payment for the new Type-1 fire engine in the current fiscal year 24-25. This action will fulfill the City's remaining financial obligation for the fire engine purchase and support the ongoing fire department reorganization process.

### PUBLIC COMMENT:

As of the writing of this staff report, staff has not received any public comments. If staff receives public comment from interested parties following the publication and distribution of this staff report such comments will be provided to the City Council as supplemental materials before or at the meeting.

### **COMMUNITY OUTREACH:**

This item has been noticed in accordance with the Ralph M. Brown Act and was available for public viewing and review at least 72 hours prior to the scheduled meeting date. The City has also used social media to promote and advertise the City Council Meeting Agenda Items.

## FISCAL IMPACT:

Although Measure H fund has sufficient resources to cover this final payment, there was no prior appropriation authority for such an expenditure. Consequently, staff is requesting a budget adjustment of \$231,335.50 from the Measure H fund to settle the City's debt financing obligation. This adjustment will ensure that the necessary funds are allocated to cover both the principal and interest amounts.

Specifically, the budget adjustment will be allocated as follows:

- Account code 248-99-74-6100 for the principal amount of \$212,689.97
- Account code 248-99-74-6200 for the interest amount of \$18,645.53

This adjustment is essential to ensure that the City meets its financial obligations. The Measure H fund will be utilized effectively to cover the debt.

## **OPTIONS:**

Approving this budget adjustment of Measure H funds will save money by reducing the financed interest paid. The council can choose not to authorize using Measure H funds and pay projected interest as outlined in the lease agreement.
