What President Trump's Executive Order Does

- 1 Limits federal support for Housing First HUD and HHS are directed to revise regulations, grant requirements, and guidance to end support for Housing First policies that, in the administration's view, deprioritize accountability and fail to promote treatment, recovery, and self-sufficiency.
- 2 Conditions housing assistance on behavioral health treatment HUD and HHS are instructed to ensure federal housing programs require, where possible, active participation in treatment for substance use disorders or severe mental illness.
- **3 Prioritizes support for jurisdictions enforcing public safety laws** Agencies are directed to prioritize jurisdictions that enforce bans on urban camping, loitering, squatting, and open-air drug use when awarding discretionary grants.
- **4 Encourages expansion of involuntary civil commitment** DOJ is directed to seek reversal of judicial precedents and consent decrees that limit civil commitment and to support states in adopting more flexible commitment and treatment laws.
- 5 Restricts harm reduction efforts DOJ must assess whether federally funded organizations that operate safe consumption sites, distribute drug paraphernalia, or allow on-site illicit drug use are violating federal law, and initiate enforcement actions where applicable.
- **Mandates interagency data sharing with law enforcement** HHS, HUD, and DOJ are instructed to develop policies to collect and share behavioral health and homelessness data with law enforcement authorities, where permitted by law.

Note element #3 of the summary describes favoring cities that enforce bans on urban camping, loitering, squatting an open air dr use when awarding discretionary grants.

All of this is very complex. It is not known at this time how California will respond. Housing First is a principle built into every law, regulation and program in California. Will California make changes to these laws regulations and programs? Will HUD hold up funds until changes are made? Does California have deep enough pockets to make up for potential freezes to existing housing vouchers. What will happen to future vouchers for facilities like Gravenstein Commons that have not opened.

Who in the city is talking to our state and federal legislators to get advice and guidance. Who is talking to the other cities and counties who got the third wave of grants. Does the California League of Cities have a forum where these issues are being discussed?

What do our consultants say. We seem to have at least two consultants being paid and Mark Krug who did the initial assessment of this project. When will we hear from them?

Our prior city manager explained the complexity of these programs and the city's lack of expertise and manpower to manage it properly. Today the city has less expertise and less manpower.

The City Council is the entity responsible. A prior council voted for this against the recommendation of city staff. The mayor is responsible for signing all related documents. There are options for the City Council to consider:

- 1. Pause construction until all money for construction and the promised contingency funds is in the bank for both capital contingency and operational contingency.
- 2. For a temporary ad hoc to meet at length with consultants, political representatives, consult the league of cities and to put together something that looks like a viable PLAN.
- 3. Meet privately with SVdP to discuss other options for the property that may be preferable to them as well. He has publicly stated that taking drug addicts and alcoholics is not his preference. The city needs more low-income housing, not more housing for other cities recently homeless. Sometimes new information gives everyone new ideas.
