- B. **6780 Depot St., Suite 160 Alcohol Use Permit** – A public hearing for an application from Martin Maigaard for an Alcohol Conditional Use Permit at The Wild Poppy Café located at 6780 Depot St, Suite 110. The application is requesting a Type 41 on-and-off-sale beer and wine alcohol license to complement the new restaurant and market. The restaurant will offer locally sourced foods available for counter service, grab-and-go, and bakery items. The focus will be on daytime service, open from 10:00 am – 6:00 pm every day, and open until 8:00 pm Thursday through Saturday.

PUBLIC HEARINGS AND PUBLIC COMMENT ON ITEMS

The City of Sebastopol wishes to foster a constructive, respectful, and open process through its meeting procedures. Members of the public have the right to speak on all public hearings under discussion by the Planning Commission including consent calendar items, after being properly recognized by the Chairperson. The Commission requests that members of the public refrain from expressions of approval or disapproval (clapping, booing, hissing) of statements of other participants, which discourages the expression of a range of viewpoints, as well as lengthening meetings. The following is the hearing process:

1. The Chairperson opens public hearing.
2. Presentation of Staff Report from the Planning Department.
3. Commission Questions of Staff.
4. Presentation by the Project Applicant, Questions of Applicant from Commissioners. Applicant presentations should generally be limited to approximately 10 minutes or less.
5. Comments from members of the public. Comments should be limited to 3 minutes or less. Comments from the public will be taken for both in-person and Zoom attendees.
6. The Chairperson may request that the applicant or staff respond to specific issues raised in the public comments.
7. The Chairperson closes the public hearing, but reserves the right to re-open the public hearing later that evening.
8. The Planning Commission deliberates on the project. Commissioners discuss the project; applicant or public comment is not permissible unless allowed by the Commission.
9. The Chairperson may re-open the public hearing to give the public or applicant the right to comment on the Planning Commission deliberation or bring forth new information to the Commission.
10. The Planning Commission takes action on the project by making one or more motions to approve, condition, deny, or continue (schedule further consideration for a future meeting) the matter.
11. Appeals may be filed of official actions upon filing of an appeal form and payment of the applicable appeal fee. Such appeals, including the appeal fee, must be filed within 7 days of the action. Appeals will be heard by the City Council.

STAFF REPORTS ON AGENDIZED ITEMS are available for review on the City's website: www.cityofsebastopol.gov/city-meeting-calendar/ Reports are generally issued and posted by 6 p.m. on the Thursday before the meeting. Interested persons are encouraged to review these reports, which evaluate proposals relative to adopted laws and policies.

LETTERS OR WRITTEN MATERIALS regarding agenda items may be submitted to the Planning Department prior to or at the Commission meeting; written materials submitted at least six days in advance of the meeting will be included in the Commission's meeting packet. The public is advised that pursuant to State law, written submittals to the City are public records, will be made available for public review, and may be posted on the City website. Public Comment can be emailed to the project planner listed in any notices, or vhenkel@cityofsebastopol.gov.

Public Comment While Attending City Meetings Through Zoom Virtual Platform?

Public Comment for items not on agenda, Informational Items, Public Hearing and Regular Calendar Item(s) all allow public comment. Once the Chair announces public comment period, please do one of the following:

USING A COMPUTER OR SMART PHONE: Click on the “Raise Hand” feature in the webinar controls. This will notify the Meeting Host that you have raised your hand.

USING A REGULAR PHONE: Dial *9 (star 9), this will notify the Meeting Host that you have “raised your hand” for public comment.

- Meeting Host will ask you to unmute your microphone when it is your turn to provide public comment.
- You will have three minutes to provide public comment.
- Once your public comment has ended, please mute yourself (or the host will mute your sound).

I don't want to provide public comment live; can I provide my public comment for the record another way? Please submit all public comments via email or mail (to City Hall) for inclusion into the public record. You may also leave a voice mail that will be made a part of the public record (but will not be read into the record). Please call 707-823-6167 to leave a message (by recording or comments provided verbally to City staff). If recorded, your voicemail will be transcribed and made part of the public record but will not be read at the meeting.
