Subject: Lowering the Age of Youth Applicants Discussion and Action

---

**Background:**

The Climate Action Committee (CAC) consists of seven (7) members, including one (1) City Councilmember and six (6) community members. Committee membership is intended to reflect a range of experience and perspectives related to climate action, sustainability, and community engagement. Membership categories include:

- One (1) City Councilmember
- Youth Representative (currently ages 17–23)
- Climate Change Background
- Sebastopol Business Owner
- Local Climate Action Group Representative
- Environmental Justice & Equity Background
- Rights of Nature Background
- Energy Background
- Transportation Background

The current Youth Representative category requires applicants to be at least seventeen (17) years of age. During the most recent recruitment process, staff received applications from two (2) interested youth applicants who were fifteen (15) years old and therefore did not meet the current eligibility requirements.

The CAC requested that staff explore the possibility of lowering the minimum age requirement for the Youth Representative position from seventeen (17) to fifteen (15) years of age to encourage broader youth participation and engagement in local climate action efforts.

To evaluate potential liability and participation considerations, staff consulted with the City's insurance provider, California Intergovernmental Risk Authority (CIRA). CIRA provided recommended parental/guardian consent language for youth applicants under the age of eighteen (18). The proposed consent language has been incorporated into the Youth Application and is attached for review.

Because the age requirement is established by City Council action, any amendment to the Youth Representative eligibility criteria would require City Council review and approval.

**Discussion:**

The Committee may wish to discuss whether expanding eligibility to include applicants ages fifteen (15) and sixteen (16) would further the City's goals of youth engagement, civic participation, and climate leadership development. Lowering the minimum age requirement could increase the pool of interested applicants and provide younger residents with an opportunity to participate in local government decision-making related to climate policy and sustainability initiatives.

If the Committee wishes to pursue a change to the age requirement, the matter must be referred to the City Council for consideration.

**Option 1 – CAC Referral through Agenda Review Committee**

The CAC may direct staff to request that the Agenda Review Committee place the item on a future City Council agenda for discussion and possible action. This direction would be provided through a motion adopted at a regular CAC meeting.

**Option 2 – Council-Sponsored Agenda Request**

The CAC may ask a City Councilmember to sponsor the topic for consideration at a City Council meeting. A second Councilmember would need to support the request at that meeting. If supported, the item would then be referred to the Agenda Review Committee for scheduling on a future City Council agenda.

**Recommendation:**

Provide direction to staff regarding whether the Committee wishes to pursue a recommendation to the City Council to amend the Youth Representative eligibility requirement from ages 17–23 to ages 15–23 and, if so, which process the Committee would like to utilize for bringing the matter forward.
