RECOMMENDATION(S):

That the City Council receive a presentation from staff regarding a conceptual proposal for a small soccer facility sponsored by WESCO United Soccer Club and provide general direction regarding potential locations and whether staff should continue evaluating feasibility.

EXECUTIVE SUMMARY:

Staff has been approached by representatives of WESCO United Soccer Club regarding the potential installation of a small format soccer facility, commonly referred to as a mini-pitch, within the City of Sebastopol. The proposed facility would provide a compact soccer court designed for smaller sized games, youth training, and informal community recreation.

At this time, staff is bringing the concept to the City Council to obtain initial feedback prior to committing significant staff resources to site feasibility analysis, permitting review, or partnership development. Two potential locations have been identified for preliminary discussion: the gravel and parking area behind the Youth Annex building and a vacant privately owned parcel located across from Sebastopol Main Square/Downtown Plaza.

The purpose of this agenda item is to provide an overview of the concept and allow the City Council to provide direction on whether staff should continue evaluating the proposal and potential sites.

BACKGROUND AND DISCUSSION:

WESCO United Soccer Club is a regional youth soccer organization that provides programming and training opportunities for youth players and families throughout West Sonoma County. Representatives of the organization have expressed interest in partnering with the City to develop a small format soccer facility that could support youth programming while also providing an accessible recreational amenity for the broader community.

Mini-pitch soccer courts are smaller than traditional soccer fields and are designed to accommodate smaller games. These facilities are typically constructed using a durable playing surface with perimeter containment, lighting, and seating areas for spectators. The facilities can support a range of activities including youth training sessions, informal community play, and small tournaments or events.

Preliminary information provided by WESCO indicates that the facility could consist of one or two mini-pitch courts depending on site constraints and layout. The anticipated field dimensions are approximately 85 to 90 feet in length and 40 to 45 feet in width, although the final configuration would depend on site conditions.

The project concept includes a contained field area, perimeter netting or fencing, small spectator seating areas, lighting, and an all-weather playing surface designed to support year-round use. Installation typically involves preparing a level base surface and installing a modular playing system.

WESCO has indicated that funding for the project could potentially be provided through private donors, sponsorships, and organizational contributions. City fees for application and staff time would be required. See details below in the fiscal impact section of this report.

1. Youth Annex Parking Lot Location

The first potential location is the gravel and parking area behind the Youth Annex building. This property is owned by the City and is located adjacent to the Laguna wetlands area. Conceptual layouts provided by WESCO illustrate the potential placement of one or two mini-pitch courts within the existing open gravel area while maintaining circulation and portions of existing parking. The location is centrally located within Sebastopol and is in proximity to youth recreational facilities and community amenities.

Public Works Consideration:

Stock Yard: Public Works has reviewed the conceptual layout of the proposed mini-pitch soccer facility behind the Youth Annex. Public Works has concerns about the potential loss of operational stock yard space currently used for material storage, equipment staging, and other Public Works activities. With several capital improvement projects anticipated in the coming years, including potential flood-related work, maintaining adequate space for materials handling and staging will be important. If the facility is located entirely within the existing gravel parking lot and does not encroach into the operational stock yard area, Public Works would not have concerns with the proposed location.

Conservation Easements: Staff confirmed with the Sonoma County Agricultural Preservation and Open Space District that this parcel is part of Youth Park and is not subject to conservation easements that would prohibit this recreational use.

100-yr Floodplain: The site is located within the mapped floodplain. Because the proposed mini-pitch consists primarily of a playing surface and netting that would not impede floodwaters, Public Works does not anticipate the floodplain location presenting a concern, though the final design would need to comply with applicable floodplain regulations for structures designed in an active floodplain.

Drainage: The Youth Annex site is located adjacent to the Laguna de Santa Rosa. Any drainage generated by the proposed mini-pitch facility must be managed away from the Laguna. Public Works would require that stormwater runoff from the field be directed to an appropriate drainage feature, such as a swale or rain garden, designed to capture and infiltrate runoff onsite. If the project includes surface cleaning using water, any wash water must be directed to the sanitary sewer. Discharges to the sanitary sewer may require advance coordination with the City to determine whether a wastewater discharge permit, applicable fees, or pretreatment are required prior to discharge. Approval must be obtained prior to any discharge, and all activities must comply with City sanitary sewer use requirements. Public Works expects these improvements to be designed and constructed by the project sponsor as part of the project.

Maintenance: If the project moves forward, Public Works requests that the facility remain open to the public and that all construction, grading, installation, and maintenance be the responsibility of the project

sponsor.

The associated Public Works costs for this location would be roughly as follows:

1. Plan Review – City Engineer: \$500
2. Staff Time Agreements: \$750

Planning Considerations:

Environmental & Stormwater

Several potential environmental concerns arise due to the site's proximity to the Laguna de Santa Rosa. The proposed soccer field would require hard compaction fill, which has the potential to disrupt the existing natural groundwater percolation on the site. A change in surface conditions would accelerate stormwater runoff, reducing the land's natural capacity to filter contaminants — such as vehicle oils, sunscreen, and other materials — before they reach the Laguna. If the facility is placed entirely within the existing hard packed parking area, most of this concern would be eliminated. Staff would also be concerned about runoff generated during routine field maintenance and periodic cleanings, as those flows could carry additional pollutants into the adjacent Laguna unless correctly managed.

Lighting & Nocturnal Habitat

The project includes lighting to support nighttime use. Given the site's adjacency to the Laguna, staff is concerned about the potential impact of artificial lighting on nocturnal wildlife habitat in the area. The full extent of this potential impact cannot be known without a biological study to examine nighttime lighting effects.

Parking

The area currently serves as overflow parking for Laguna trail users and converting it to a soccer field would reduce that capacity. The application does not specify the seasons or hours during which the field would be in use, which makes it difficult to fully assess parking demand. However, given that baseball is active at both Community Center fields in the spring and fall, and that the Community Center regularly hosts special events, the addition of a soccer facility could create parking conflicts during periods of overlapping use.

Permitting & Use Agreement

Given the private nature of the WESCO facility and its proposed location within an ESOS Overlay Zone, a use permit would be required. Because the site is on City-owned property, staff recommends that the City and WESCO enter into a formal use agreement addressing liability and related matters, similar to the arrangement currently in place with Little League for the baseball fields at the Community Center (Clahan Fields) and Polley Field at Ives Park.

CEQA

Due to the site's proximity to the Laguna, the ESOS Zoning Overlay, and the inclusion of nighttime lighting, CEQA review should be anticipated as part of the entitlement process.

Cost

The associated costs for this location would be roughly as follows:

3. Use Permit: \$3000 (minimum deposit)
4. CEQA: \$6000 deposit + \$3000 filing fee (additional fees may apply if special studies are required)
5. Partnership Agreement: \$5000 deposit (to cover staff and legal cost to negotiate and draft)

partnership agreement).

Legal Considerations:

Because this proposed use is on City property, an agreement between the City and WESCO would be necessary. The Agreement would require WESCO to obtain insurance as well as to indemnify, defend, and hold the City harmless for any liability arising out of the proposed use. That would significantly limit any liability exposure for the City. The Agreement would also regulate the use of the field in more detail than is typical for private property. For example, the Agreement would require the property to be open to the public for certain periods of time. The Agreement would also make WESCO responsible for maintenance, although if the field is reserved for public use a significant portion of time, WESCO may seek to share maintenance costs with the City. The Agreement would specify how long it remained in effect. All of these terms would be negotiated by the staff, subject to final approval by the City Council.

2. Piazza Hotel Lot

The second potential location is a vacant privately owned parcel (Piazza property) located across from Sebastopol Main Square/Downtown Plaza. Development of a mini-pitch facility on private property would require coordination with the property owner as well as review of zoning, permitting requirements, and potential agreements between the City and the property owner.

Public Works Consideration: Public Works has no concerns.

Planning Considerations:

Site Concerns – Downtown Core Location

The proposed Downtown Core site presents several significant challenges that staff believes make it unsuitable for a soccer field or sports park use.

Land Use & Zoning

The Downtown Core zoning district does not permit a soccer field or sports park use, even on a temporary basis. In order to proceed with the WESCO request on this site, the City Council would need to amend the City’s Zoning Code to allow these types of private sports facility uses within the Downtown Core. While environmental impacts at this location may be somewhat less pronounced than at the Community Center site, they remain a consideration.

CEQA

The subject site is constrained by the potential presence of archeological resources, and further evaluation would be required to determine whether the level of site disturbance proposed would negatively impact resources. On-site monitoring would likely be required for any ground-disturbing activities. The proposed lighting for nighttime play would also need to be evaluated to ensure that it does not pose a lighting and glare hazard to oncoming traffic as drivers negotiate the sharp turns here.

Safety

The site is situated within a tight turn on high-traffic corridor (Highway 116) where vehicle speeds can exceed 25 mph. Staff has serious concerns about the safety of both patrons and drivers, particularly given the likelihood of young children participating in field activities. The site does not provide a safe or designated area for drop-off and pick-up, and the proximity to active roadways creates a risk in the event a child enters the sidewalk or street unexpectedly.

Parking

Parking availability at this location is considerably more limited than at the Community Center site. The nearest public parking is a City-owned lot located across the street to the north, offering approximately 40 spaces. While 40 spaces may prove adequate for the proposed facility, it would mean a loss of these spaces available for both retail and public-serving uses within the downtown.

Public Access & Downtown Compatibility

Staff has concerns about the appropriateness of a private, non-public sports facility occupying a prominent site within the Downtown Core. A location of this visibility and centrality would be better suited to a use that is open and accessible to the broader public. If the facility were made publicly accessible in a meaningful way, it could contribute to activating this downtown space; however, as proposed as a private use, it does not align with the City's goals for this area as set forth in the General Plan

Economic Impact

Finally, staff is concerned that allowing this project to move forward on anything, but a very temporary basis would effectively preclude the development of the approved Hotel Sebastopol on this site. That project represents a meaningful opportunity for the City to expand its tax base through Transient Occupancy Tax (TOT) and local sales tax revenues, and its loss would be a significant fiscal consequence that warrants careful consideration.

Cost

The associated costs for this location would be roughly as follows:

1. Rezone/Text amendment: \$5,000 minimum deposit
2. CEQA: \$6000 deposit + \$3000 filing fee (additional fees may apply if special studies are required)
3. Archeological monitoring costs are unknown at this time

Legal Considerations:

As discussed above, an amendment to the Zoning Code would be necessary to establish the proposed use as either permitted or conditionally permitted. If the Zoning Code is amended and the use established, it could likely continue in perpetuity even if the Code change is later reversed. While the current owner of the site indicates it is committed to pursuing the approved Sebastopol Hotel, if that does not occur, the soccer field would have the right to continue permanently. Because this proposed location is private property, the City would not be a partner in the operation of the site and the operator would decide if/when it would be open to the public. Because it is privately owned and operated, there would generally not be any new liability risk for the City.

STAFF ANALYSIS:

The proposed mini-pitch facility could provide an additional recreational amenity within the City and may support youth programming as well as informal community use. These types of facilities are designed to accommodate smaller games and can operate year-round due to the durable playing surface.

At this stage, the project is conceptual and staff has not conducted a detailed analysis of site feasibility, environmental constraints, or operational considerations. If the City Council expresses interest in further evaluating the concept, staff would return with additional information regarding site suitability, permitting requirements, partnership structure, and operational considerations.

CITY COUNCIL GOALS/PRIORTIES/ AND OR GENERAL PLAN CONSISTENCY:

This agenda item supports City Council goals related to community vitality and recreational opportunities within the City of Sebastopol if located on the Youth Annex property. General Plan policies would also generally be supported with a temporary (one year) use of the downtown site if the City Council determines that a change to the allowed uses within the Downtown Core Zone is appropriate. The potential project could provide an additional recreational amenity for youth and families and support opportunities for community gathering and physical activity.

FISCAL IMPACT:

At this time the City has not committed funding for the proposed project. WESCO has indicated that the project may be funded through private sponsorships, donors, and organizational contributions. Should the project move forward, any agreements between the City and WESCO would need to clearly define funding responsibilities, maintenance obligations, and operational responsibilities.

COMMUNITY OUTREACH:

This item has been noticed in accordance with the Ralph M. Brown Act and was available for public viewing and review at least 72 hours prior to the scheduled meeting date. The City has also used social media to promote and advertise the City Council Meeting Agenda Items.

As of the writing of this staff report, the City has not received any public comment. However, if staff receives public comment from interested parties following the publication and distribution of this staff report such comments will be provided to the City Council as supplemental materials before or at the meeting.

RESTATED RECOMMENDATION:

That the City Council receive the staff presentation regarding the conceptual soccer facility proposal and provide direction on whether staff should continue evaluating the feasibility of the project and potential locations. Should the Council direct staff to proceed, further review incorporating the issues and considerations identified in this report would be required, along with a deposit from Wesco Soccer to cover associated staff time and evaluation costs.

CITY COUNCIL OPTIONS:

1. Provide direction to staff to continue evaluating the proposed mini-pitch soccer facility and potential locations.
2. Provide alternative direction to staff regarding the concept or potential sites.
3. Decline to pursue the proposed project.

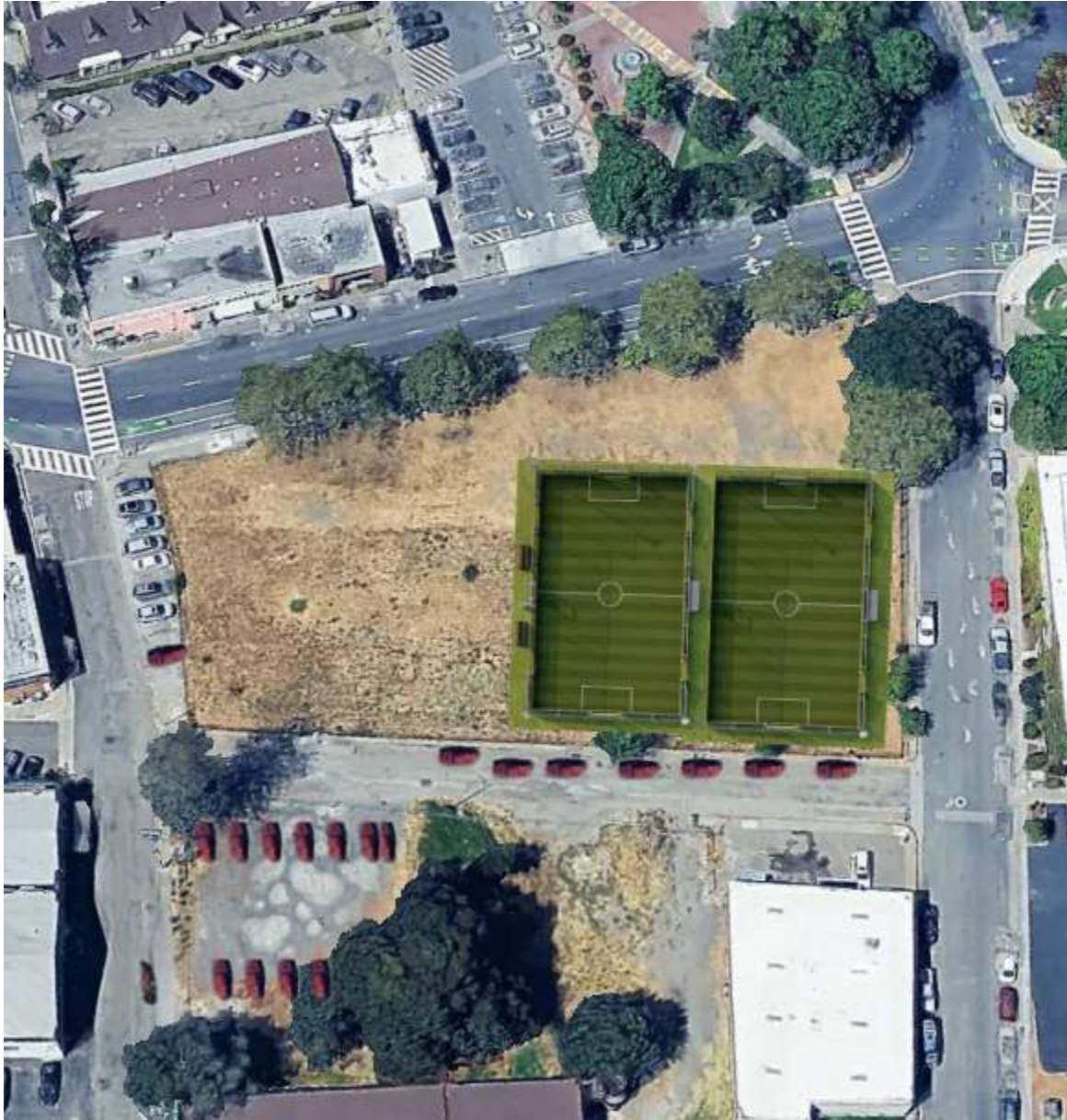

Dear Mary,

I am writing to express my enthusiastic support for WESCO United's proposed temporary soccer courts/fields on our downtown parcel bounded by Petaluma Avenue, McKinley Street, Brown Street, and Depot Street.

As you know, we currently hold a Development Agreement with the City to construct our Hotel Sebastopol project on this site, with entitlements in place through the summer of next year. We recognize that this project has been a long and complex journey, and we are deeply appreciative of the City's continued partnership, patience, and support as we work toward a successful and responsible groundbreaking.

In the interim, we have been committed to ensuring the site contributes positively to the community rather than remaining dormant. Over the past year, we were pleased to host several temporary activations, including the Sebastopol Center for the Arts installation and Bloomfest, both of which demonstrated the value of community-oriented uses that bring energy and visibility to downtown. We've also expanded and formalized the walking pathway along our McKinley Street frontage, pushing back our fence, compacting gravel, and adding string lights for nighttime safety and visibility. These experiences reinforced our belief that temporary activation can serve both immediate community needs and long-term development goals.

Looking ahead, we view WESCO United's proposal as an ideal next step. The temporary soccer courts represent a community-serving use that promotes youth engagement, healthy activity, and inclusive recreation, while also drawing consistent foot traffic into the downtown core. This increased activity would naturally benefit nearby restaurants, bars, retail shops, and other small businesses, supporting the City's broader economic vitality goals.

Importantly, approval of this temporary use would not diminish the likelihood of the hotel project moving forward. In fact, we believe it strengthens the project's prospects by allowing additional runway as lending conditions continue to improve. As interest rates stabilize and financing becomes more attainable, this flexibility may also reduce the need for more aggressive value-engineering measures, ultimately supporting a higher-quality project that better aligns with the City's expectations and the community's long-term interests.

WESCO's expressed a need for two to three-years use of our site to make it worth the economic investment. As such, it would require a brief extension of our Development Agreement, as I'm sure you're aware. We are committed to working with you and Council on that effort should it be supported.

On a more personal note, as a lifelong soccer player and fan, I am particularly excited by this proposal, especially in light of the upcoming World Cup and the opportunity it presents to celebrate the sport and bring people together in a shared, positive way.

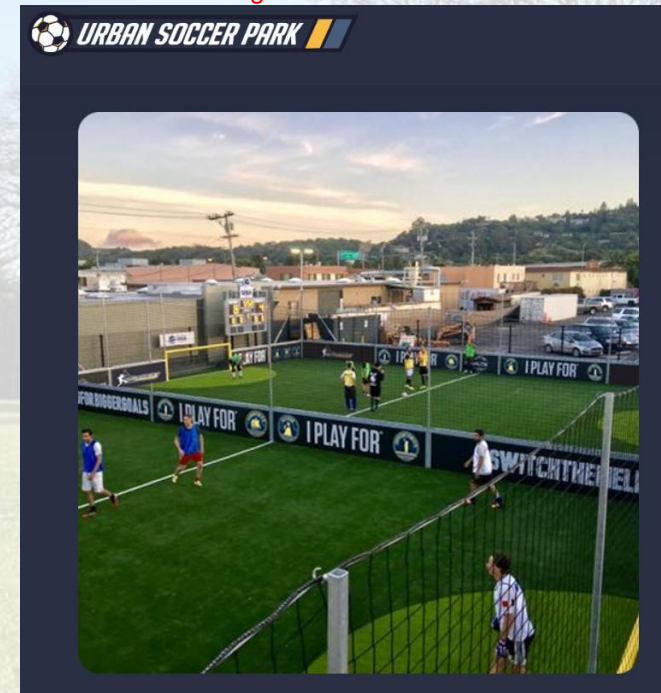

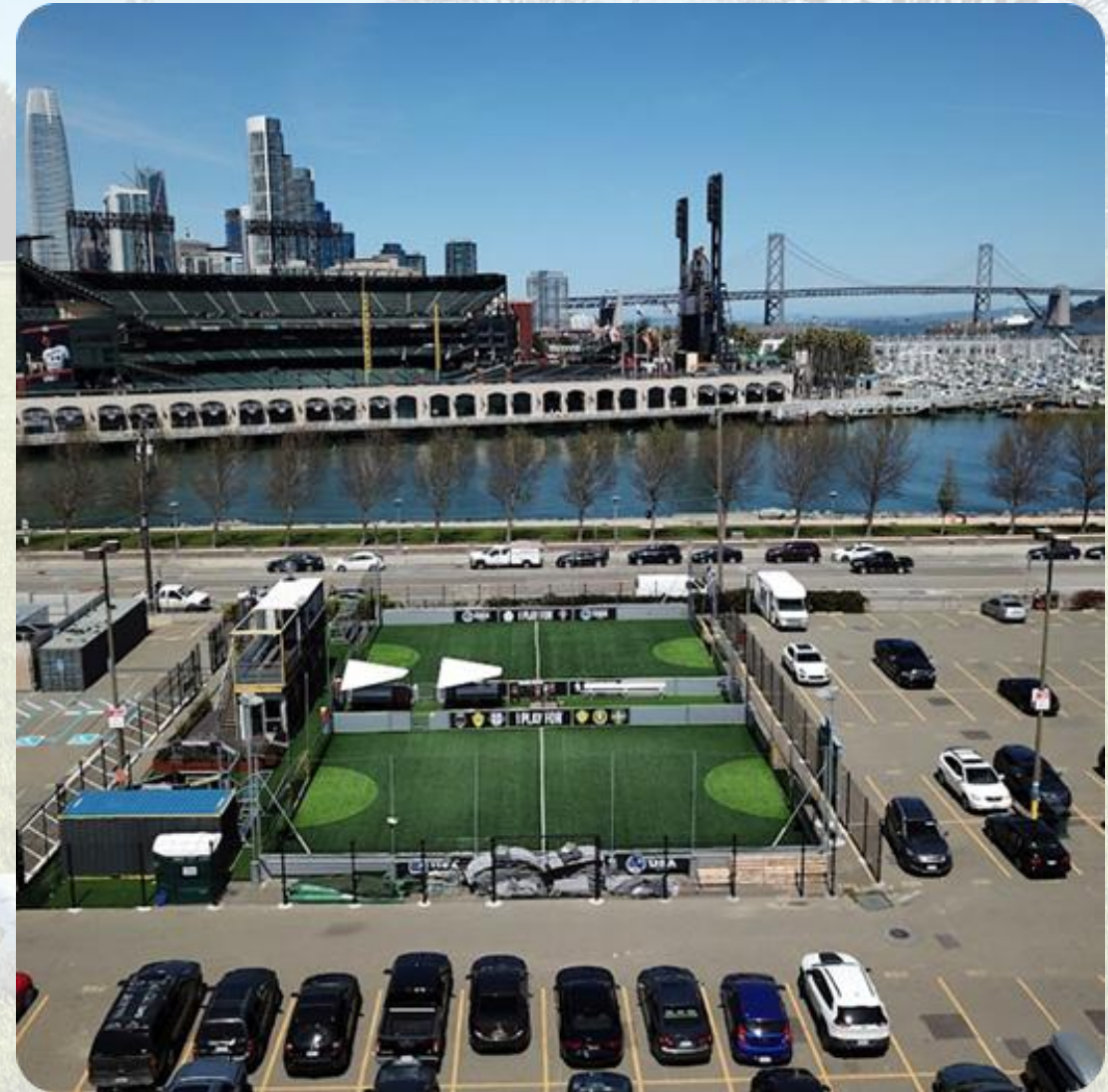

Subject: Dedicated Soccer Fields

Dear Sebastopol City Council,

I am writing as a parent and community member to strongly support the development of dedicated soccer fields in Sebastopol.

Last year, my daughter and I moved from Cloverdale to Sebastopol. At the time, she was 12 years old and entering a completely new environment without a single established friendship. As a parent, that transition was incredibly difficult to watch, she felt isolated, disconnected, and unsure of where she belonged.

Soccer changed everything.

Through access to local soccer opportunities, she was able to meet other kids, build friendships, and begin to feel a sense of belonging in this community. What started as a sport quickly became her bridge into connection, confidence, and stability during a major life transition.

Sebastopol is a community that values connection, wellness, and supporting families. Investing in dedicated soccer fields is a direct investment in our children and in the strength of our community as a whole.

I urge you to consider the real, human impact this decision has. My daughter's ability to feel at home here was made possible through soccer. Every child deserves that same opportunity.

Dear Members of the Sebastopol City Council,

I am writing as a local parent and community member to share my perspective on youth soccer field access and conditions in Sebastopol, an issue that I believe deserves thoughtful attention and meaningful action for the benefit of our community as a whole.

Soccer plays a powerful and multifaceted role in our community. It supports children's physical health, fosters teamwork and resilience, provides a positive social outlet, and creates a strong sense of belonging for families across diverse backgrounds. For many kids, it is not just a sport; it is a cornerstone of their development and connection to the broader community.

However, the current state of field access and conditions presents significant challenges.

One of the most pressing issues is limited access to playable fields, particularly at local schools, where children, coaches and families are regularly harassed by neighboring residents. I'm sure this is no surprise, given the very loud and selfishly entitled behavior of one particular resident behind Brook Haven Middle School. Due to time constraints and limited fields, it is not uncommon to see seven or even eight teams sharing a single field at the same time. This level of overcrowding diminishes the quality of play and development, increases the risk of collisions, and makes it difficult for coaches to run effective practices. It also reflects a clear mismatch between the demand for youth sports and the infrastructure available to support it.

Equally concerning is the condition of many of our grass fields. Several are in dangerously poor shape, riddled with large holes, uneven ground, and gopher mounds. While these hazards are understandably difficult to avoid, they are not minor inconveniences; they pose a real and ongoing risk of injury. Knee and ankle injuries are not uncommon under these conditions, and as a parent, it is deeply concerning to watch children play on surfaces that feel unsafe. These conditions, primarily observed at Ragle Ranch Park, make the need for expanded access to turf fields even more essential.

This is not simply a matter of convenience, but a matter of safety, equity, and community wellbeing. Families in Sebastopol should be able to rely on safe, accessible recreational spaces for their children. Youth sports organizations should not have to navigate such significant limitations in order to serve our community.

I respectfully ask the City Council to consider:

- Expanding access to existing turf fields through improved scheduling partnerships with schools and community organizations
- Investing in field maintenance and repair to address safety hazards, specifically at Ragle Ranch Park
- Exploring opportunities for additional field development or shared-use agreements
- Engaging with local soccer clubs and families to better understand current needs and future demand

Sebastopol has a strong tradition of valuing community, health, and youth development. Addressing these field challenges would be a meaningful step toward upholding those values and ensuring that all children have the opportunity to play safely and thrive.

I am writing to urge you to prioritize investment in a new, well-maintained soccer field at Ragle—one that is safe, playable, and able to meet the needs of our community’s growing number of young athletes.

As a mother of two children, ages 11 and 13, I have seen firsthand the value of youth soccer. My children have worked hard, including participating in fundraisers, to be part of the growing WESCO soccer community. Through their involvement, they have built strong friendships, developed skills, and learned the importance of teamwork. Just as importantly, our family has felt a deeper sense of connection by being part of something larger and positive in our town.

We live just west of town [REDACTED]
My kids (daughter & son) play(ed) on WESCO teams and have done for 5+ years.
I have played and coached professionally across the US and in several countries.**

Hello City Council members and City Executives.

For the past 3 years, I have been talking locally about and suggesting a public/private partnership that could / would utilize space in Central or very near Downtown Sebastopol. The idea being to create several 'soccer courts'. These are highly popular mini arenas that are 'caged' or 'contained' with boards and netting and have highly targeted LED lighting - not flood lights. Soccer Courts are extremely efficient small space training and match play venues, that can facilitate and turn over a lot of players/teams, much more efficiently than a typical soccer field. Roughly the size of tennis courts and surfaced most often now with an artificial turf, some concrete (like tennis & pickle), or as is the case in many European Mediterranean countries also using an 'ash' surface - much like a baseball infield.

I originally sent a version of this letter below in 2024 after observing and talking with community stakeholders since Fall of 2023. Nobody appeared to be thinking several years out. I started to engage briefly with people like high

school head, Chuck Wade at Analy HS and City Council member Stephan Zollman and others, in an attempt to find possible shared space and help bring about the realization that community sports programs were/are running short on space.

I believe that if a community has a vibrant sports culture which needs more space, it is actually a good problem, if we want more healthy kids (and adults) off screens.

Eventually, in my many conversations, it was Brian Heacock (WESCO Director of Coaching) who listened and shared the same concern and vision.

WESCO Soccer is very fortunate to have a very experienced, passionate and knowledgeable life long West County resident and soccer legend.

Brian grew up playing soccer locally, when culturally, it was a 'second' sport to many people at best. Yet he flourished and eventually played the highest levels of youth soccer, College and then Semi Pro, then as a soccer dad, as well as working in the youth coaching world as both a volunteer and professionally. He has also coached Analy HS.

Brian then brought into this conversation, Phil Carter, a WESCO board member who was also quick to see the virtues (community, youth, sport, health, commercial) of the soccer courts idea. Since our initial meeting/discussion, Mr Carter has been genuinely pursuing the potential and his energy and determination are highly commendable. He wants to get ahead of a very real looming issue by being creative.

The 'homeless' status of the playing facilities of the Sebastopol Youth Soccer Community, including the 'primary' organization in town representing the children of West County soccer (WESCO) and their families - the fact is, that the kids and families of Sebastopol and West County soccer, despite being the largest sporting organization in the West County, does not have a 'Home'. I believe it is time to address this.

Soccer evolution:

Why, because soccer has changed significantly in the last 10 years.

I have been in Sebastopol for over 20 years, and in this time alone, the game has exploded culturally to the national stage. It is part of the fabric of family life in the US. It is no longer a sporting backwater. The younger generations of families coming into the sport do now expect more from their soccer clubs and their Parks and Rec departments.

Consequently, we have to be more creative and explore options to partner with spaces.

The new 'soccer parent' generation have themselves come through the game during their youth and young adult lives and now have kids of their own. They are more educated/knowledgeable about the game itself and are looking for quality opportunities and experiences / options for their own kids in ways perhaps that the local game has not kept up with. There are more and more families looking for more Competitive playing opportunities and that number will grow. As this happens, there could even be other soccer clubs moving into

the Sebastopol area in the next few years.

The proposed 'Soccer Courts' are a very exciting start and a compelling concept for this next generation of West County community, players and parents.

Facts:

Currently, both Tennis & Pickle Ball have numerous courts (with lighting), Baseball has plenty of fields (some with lighting), Basketball has both indoor and outdoor facilities, Skateboarding has a dedicated space, but soccer does not.

Soccer has a somewhat gypsy presence locally and squeezes into and in between the after school sport schedules, for the most part, of Analy & Brookhaven. And with additional sports continually being added to these school schedules, the 'space crunch' is worsening rapidly for all users. I want to acknowledge that it is highly commendable that schools are offering more after school activities. Not to forget the continuous conflict with residents who live adjacent to Brookhaven school.

Benefits beyond Soccer:

If said soccer courts were to become a feature in Sebastopol, it would / could potentially bring much more retail business to town, seven days a week. From existing local patrons using the courts for practice throughout the week, for matchplay on weekends and also from potential weekend tournaments year round - bringing in players, teams, families from regional visiting competitive youth clubs. Not forgetting the rather large Adult and CoEd soccer population that would love to participate in both weekday & weekend matchplay.

This concept could / would be funded by the soccer community itself. We just need the space to develop and utilize. No City funds would be required or necessary.

The closer to Sebastopol town center, the better. Ideally, space at or adjacent to the Community center would be optimal and probably the most pragmatic.

Please consider the project as a HUGE benefit to the local community and once established, the retail vibrance of Sebastopol.

We could make such a facility the centerpiece and showpiece of downtown -

'Sebastopol - A Sport Town' - Envy of the North Bay !!!!!

One of the major challenges we face as soccer teams in West County is field space shortage. Dear Sebastopol City Council Members,

I am writing to urge you to invest in building safe, well-maintained soccer fields in Sebastopol. As a parent of two youth soccer players, I have seen firsthand how urgently this is needed.

Currently, our community relies on a limited number of school fields and the fields at Ragle Ranch Park. These options are simply not adequate or safe. The park fields, in particular, are uneven and hazardous. My own family has experienced this directly: one of my sons broke his foot after stepping in a gopher hole and was out of play for nearly a year, and my other son suffered a severe toe sprain from a divot that kept him sidelined for months. Unfortunately, these are not isolated incidents—they reflect the general condition of the fields many of our children are expected to play on.

The majority of players in West County United Soccer Club (WESCO United) participate at the recreational level, and these players are often assigned to the poorest-quality fields. Meanwhile, more competitive teams must scramble to secure access to school fields, often relying on the goodwill of local schools rather than consistent community resources. This creates inequity and limits opportunities for all players.

Neighboring communities have made investments in safe, well-maintained athletic facilities, and the results are clear. Cities like Windsor, Napa, and Petaluma offer fields that are widely used, well cared for, and support both recreational and competitive play.

Sebastopol's youth deserve the same.

Investing in safe soccer fields is an investment in the health, safety, and well-being of our community's children. It supports physical activity, teamwork, and a strong sense of community. Most importantly, it ensures that our children can play the sports they love without unnecessary risk of injury.

I strongly encourage the Council to prioritize the development of new, safe soccer fields for Sebastopol. Our community has outgrown the current facilities, and it is time to provide the infrastructure our families need.
