EXECUTIVE SUMMARY:

Each standing committee (Planning Commission, Design Review Board, Public Arts Committee, and Climate Action Committee) has completed and adopted a Fiscal Year 2026–2027 Work Plan, which is attached to this staff report for City Council review and approval.

The Work Plans provide a framework for committee priorities, projects, and objectives during the 2026–2027 fiscal year and are intended to support the City's goals and strategic priorities.

BACKGROUND:

The adoption of Work Plans for each standing committee helps ensure that elected officials, appointed committee members, staff, and the public are informed about the committee's priorities, projects, and anticipated activities. Work Plans promote transparency, facilitate public participation, and provide a framework for coordinating committee efforts with City goals and priorities.

Collectively, the Work Plans assist staff in allocating resources, scheduling work, and identifying opportunities for grant funding and other external resources to support committee initiatives.

Work Plans are intended to identify anticipated projects and priorities; however, they do not include routine operational matters, permit processing, development review activities, or other ongoing responsibilities that require staff and committee time throughout the year. Because the volume and complexity of these activities can vary significantly, they may affect the timing and completion of Work Plan items. Additionally, new initiatives, assignments, or priorities may be added by the City Council, committees, or staff as circumstances warrant.

DISCUSSION:

Staff worked with each standing committee to review, refine, and prioritize Work Plan items based on regulatory deadlines, grant requirements, City Council priorities, interdepartmental coordination needs, available resources, and ongoing projects. Consideration was also given to initiatives that require collaboration among multiple committees, implementation of adopted City plans and policies, and projects funded through existing grants or other external funding sources.

The resulting Work Plans reflect a balance between committee priorities, staff capacity, funding opportunities, and anticipated project timelines.

STAFF ANALYSIS:

The proposed Work Plans are consistent with City Council goals and priorities and are achievable within the upcoming fiscal year, subject to available resources, workload demands, and emerging priorities.

In conjunction with the proposed Work Plans, the Public Arts Committee has requested a return to a monthly meeting schedule. The Committee currently meets every other month, for two hours on the fourth Thursday. The Committee has indicated that monthly meetings would improve their ability to advance projects and accomplish Work Plan objectives in a timely manner. The City Council should determine if the approved Work Plan items warrant adding additional meetings. Fiscal impacts are discussed below.

The Design Review/Tree Board has requested a return to meeting twice per month. The Board currently meets once a month for two hours on the fourth Tuesday. Under its proposed new schedule, the Board would continue its regular monthly meeting for project and permit review and hold a second monthly meeting for 90 minutes dedicated solely to Work Plan implementation and long-range planning efforts. However, it is not clear that additional meetings are required to accommodate Work Plan implementation efforts; the DRB/Tree Board has cancelled 5 out of the 13 meetings scheduled over the last 12 months. Work Plan items might be better accommodated within the existing meeting schedule by placing them on agendas that would otherwise be cancelled.

As requested by the DRB/Tree Board, the second monthly meeting would be held in the City Hall Conference Room, remain fully compliant with the Brown Act, and would not include development review or permit-related items. If the request for additional meetings is granted by the City Council, then staff supports this approach, as the use of the Conference Room and staff-managed recording and Zoom services would reduce meeting costs by eliminating the need for outside video production services while maintaining public accessibility and transparency. This format is currently utilized successfully by the Public Arts Committee and the Climate Action Committee.

provided to the City Council as supplemental materials before or at the meeting. In addition, public comments may be offered during the public comment portion of the agenda item.

PUBLIC NOTICE:

This item was noticed in accordance with the Ralph M. Brown Act and was available for public viewing and review at least 72 hours prior to the scheduled meeting date.

FISCAL IMPACT:

There is no direct fiscal impact associated with the recommended action tonight; items included in the attached Work Plans are covered by budgeted staff salaries. Approval of the requests from the Public Arts Committee and/or the Design Review/Tree Board to have additional meetings would have minor budget impacts, as outlined below:

The estimated total annual fiscal impact for an additional PAC meeting would be \$5,376 to \$8,064. The estimated total annual fiscal impact for an additional DRB meeting would be \$7,152 to \$11,448. These additional costs could be absorbed within budgeted staff salaries, but might affect other work priorities such as application processing or long-term planning projects.

The Design Review/Tree Board members have suggested that the Chair and Vice-Chair could prepare the agenda to save costs, but under the Brown Act, this arrangement would become a standing committee and would increase staff time. It is assumed that this would be one (1) to two (2) meetings a month, similar to the Agenda Review Committee.

RESTATED RECOMMENDATION:

Staff recommends that the City Council receive the presentation, review the Work Plans, provide any input, determine whether the additional meetings of the DRB/Tree Board and the Public Arts Committee are warranted, and approve the Work Plans.
