#### EXECUTIVE SUMMARY:

The Sonoma County Mayors' and Councilmembers' Association Board of Directors and the City Selection Committee is a collaboration of all Sonoma County cities with a goal of creating a united front to represent the strongest voice possible in support of city interests. The City Selection Committee and the Board of Directors for the Sonoma County Mayors' and Councilmembers' Association and the General Membership conducts meetings bi-monthly. On February 12, 2026, the City Selection Committee and Mayors and Councilmembers Board of Directors will make appointments to upcoming vacancies on various committees.

The Board of Directors of the Association shall be comprised of the Mayors of the member cities and the officers of the Association. The officers of the Association shall have no vote unless they are Mayors. In the event a Mayor is unable to attend a meeting of the Board of Directors, he/she shall designate another member, who must be a regular member of the Association, to serve as the representative, by letter delivered to the Secretary of the Association at the time of such meeting or prior thereto. In lieu of a letter being provided prior to each meeting, cities may instead provide a letter to the Chair City at the beginning of each term designating the approved alternates for their city. By such a letter, a Mayor may designate another councilperson to serve as his/her representative on all occasions when the Mayor is absent, or only for a particular meeting or meetings. The representative shall enjoy the same voting privilege during the Board of Directors' meeting as would the Mayor he/she represents. In the absence of such a letter, no one shall be entitled to act as the representative of a Mayor. If there are no letters of interest, the by-laws of the Sonoma County Mayors' and Councilmembers' Association allows for nominations from the floor at the meeting.

### BACKGROUND:

The Sonoma County Mayors' and Councilmembers' Association (Association) represent every city within the County of Sonoma. Its voting members consist of a Mayor or alternate Councilmember from each of the member cities, chosen by their respective Councils. Their duties are to review policy items, make appointments as may be required or authorized, deal with issues affecting cities, and advocate for those on behalf of the cities within Sonoma County.

The Association engages with statewide and county agencies to provide advocacy and representation for the local area. Accordingly, the association will recruit members to serve on various boards, commissions, and committees to ensure appropriate representation.

### DISCUSSION:

The City Selection Committee, the Board of Directors for the Sonoma County Mayors' and Councilmembers' Association, and the General Membership meetings are held on the second Thursday of the months of: February, April, June, August, and October.

The Mayors' and Councilmembers' Association, which includes all the Sonoma-County cities, fill vacancies on various local or regional Boards or Commissions when the terms of office expire or upon resignation. On February 12, 2026, the Board of Directors will make appointments to upcoming vacancies on various committees.

Dear Ms. Berges,

I am pleased to submit this Letter of Interest for one of the available seats on the Charles M. Schulz Sonoma County Aviation Commission. I am currently Mayor for the City of Santa Rosa, and I am beginning my fourth year as a Council Member. Airport development issues are central to the long-term success of Santa Rosa, and critical to Sonoma County economic development. Recent Airport improvements including runway extension, terminal expansion, and the arrival of Southwest Airlines highlight the Airport's immense economic value to our County, and the importance of developing a true long-term aviation industry strategy for our City and County. We need a thoughtful approach to air traffic growth at the Charles M. Schulz Sonoma County Airport (and elsewhere in the County) that will bring economic growth while still preserving the character of Santa Rosa and our County.

I am already engaged with issues and projects adjacent to the work of the Sonoma County Airport, and I believe my experience would be an asset to the Aviation Commission:

- In my role at Sonoma State University (SSU) as Senior Director for Corporate and Foundation Relations, I am working with faculty members and donors to evaluate the possibility of SSU beginning an aviation program in partnership with the Airport and regional aviation firms.
- I began my career at Logistics.com (now Manhattan Associates), and worked on issues of transportation and distribution at firms across the U.S. and Canada;

It is important to note that, given its size and proximity to the airport, Santa Rosa is disproportionately impacted by Charles M. Schulz Sonoma County Airport issues, including neighborhood overflights, traffic, and development around the Airport. Furthermore, the population center along the Highway 101 corridor, including Santa Rosa, has been the catalyst for some of the recent airport expansion projects, including the terminal expansion and the arrival of Southwest Airlines. For these reasons, the City of Santa Rosa is very interested in being an active participant in discussions related to County aviation issues, especially those pertaining to the Charles M. Schulz Sonoma County Airport.

On a personal note, my wife and I are regular users of the Sonoma County airport, and are engaged with Airport issues as local travelers. I would be proud to serve the Sonoma County Aviation Commission as an Member. I thank the Association members for their consideration, and will be happy to provide additional information about my background and interest upon request.


