Dear City Council Members:

We, the undersigned, live in Sebastopol and demand that our City Council and City bargain in good faith with the workers who make our City run. Our workers' Union, SEIU Local 1021 and the workers have been at the negotiating table for months with the City and have faced month's long delays, bad faith bargaining and anti-union tactics. Now the City has declared the negotiations are at an impasse and the workers have little choice but to strike.

The workers are seeking an adjustment for inflation in their wage demands—a very reasonable position given that no worker can even afford to live in Sebastopol. Because of Measure U, which the Union played a major role in passing, the City reserves are now very healthy and the City can afford to help give workers a living wage.

City Council members we demand that you do all you can to make sure the City is bargaining in good faith with SEIU Local 1021 and City workers.
