

## NOTICE OF PUBLIC HEARING

Notice is hereby given that the City Council of the City of Sebastopol has scheduled a Public Hearing to consider proposed updates to the City's existing regulations on the establishment of 'formula' business uses in Sebastopol. The proposed ordinance would review and update restrictions and procedural requirements regarding specified "formula" businesses – generally retail stores or restaurants, sometimes franchises, which have standardized décor, services, uniforms, etc., which make them substantially identical to other businesses elsewhere in the United States. The purpose of the formula business regulations is to protect the unique character of Sebastopol, maintain diversity in its businesses, and ensure that the city's businesses serve the needs of the community. The proposed changes to the City's formula business regulations would prohibit some types of new formula businesses in the downtown area, and require Use Permits in certain circumstances for new formula businesses in the downtown and other areas of the City.



Comments received after posting of the agenda will be provided to the Council and made part of the public record.

If you challenge this decision in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City of Sebastopol, at, or prior to, the public hearing.
